For ad valorem tax purposes only, the address for the above described property is 413 Waterford Drive, Calera, AL 35040.



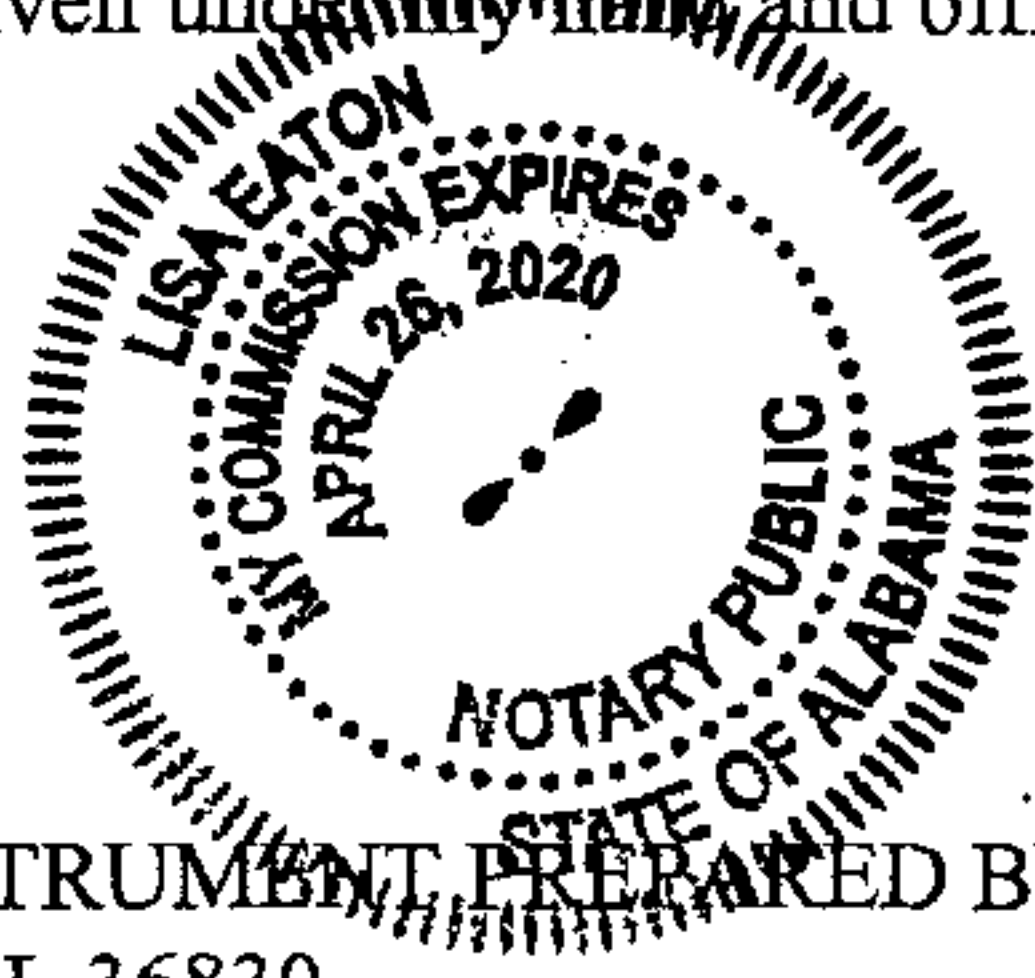

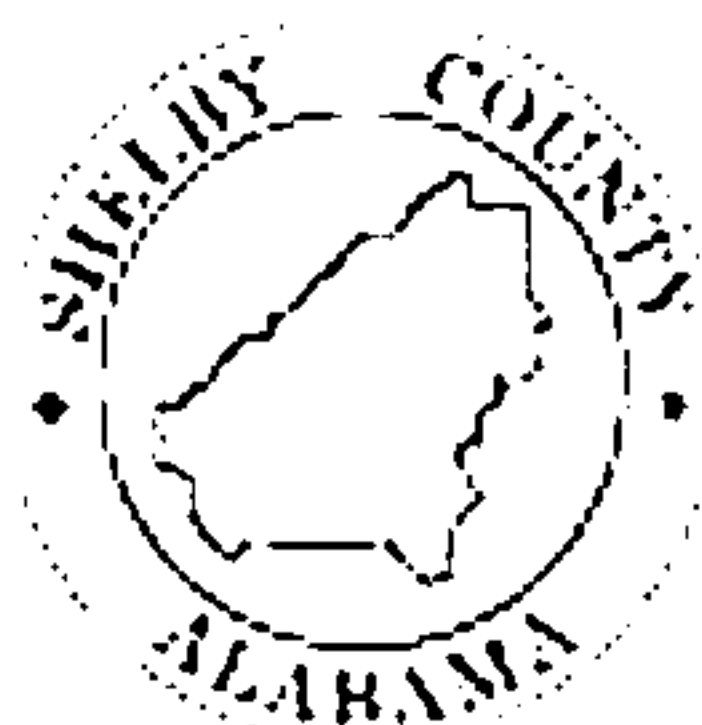
