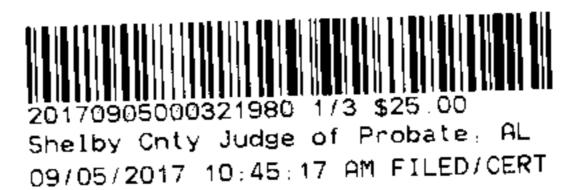

WARRANTY DEED
