FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on September 21, 2007, to-wit: Teresa A. King, an unmarried woman, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for International Mortgage Corp, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on October 2, 2007, in Instrument No. 20071002000459970 and modified by that certain Loan Modification Agreement recorded December 2, 2013, in Instrument No.20131202000466110, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to Chase Home Finance, LLC, by assignment recorded December 23, 2009 in Instrument No. 20091223000468190, and modified by that certain Instrument recorded May 22, 2017 in Instrument No. 20170522000177670, Probate Records of Shelby County, Alabama; and
