
ORDINANCE NO. 480



AN ORDINANCE APPROVING THE TRANSFER OF SURPLUS EASEMENTS

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF PELHAM, ALABAMA, AS FOLLOWS:

Section 1. It is hereby established and declared that the following described easements of the City of Pelham, Alabama, are no longer needed for public or municipal purposes:
