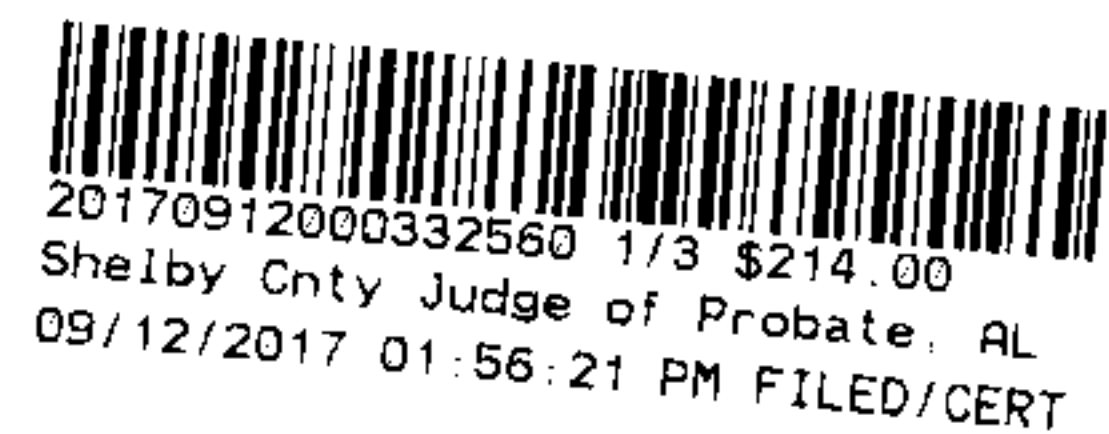

FORECLOSURE DEED

KNOW ALL PERSONS BY THESE PRESENTS: That HILLARY L. CASTLEBERRY and TIFFANY S. CASTLEBERRY, husband and wife, did, on to-wit, April 30th, 2008, execute a mortgage to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Countrywide Bank, FSB, which mortgage is recorded in Instrument No. 20080501000178540 and further modified by instrument recorded in Instrument No. 20130422000162390, et seq., in the Office of the Judge of Probate of Shelby County, Alabama; said mortgage being lastly assigned to BANK OF AMERICA, N.A. by instrument recorded in Instrument No. 20111110000339380 in said Probate Court records; and

WHEREAS, default was made in the payment of the indebtedness secured by said mortgage and the said BANK OF AMERICA, N.A. did declare all of the indebtedness secured by said mortgage due and payable and did give due and proper notice of the foreclosure of said mortgage, in accordance with the terms thereof, by publication in The Shelby County Reporter, in its issues of July 12, 19 and 26, 2017; and

WHEREAS, on August 28th, 2017, the day on which the foreclosure sale was due to be held under the terms of said notice, between the legal hours of sale, said foreclosure sale was duly and properly conducted, and BANK OF AMERICA, N.A. did offer for sale and did sell at public outcry, in front of the courthouse door of Shelby County, Alabama, in the city of Columbiana, Alabama, the property hereinafter described; and

WHEREAS, the highest and best bid for cash obtained for the property described in the aforementioned mortgage was the bid of the said R. REALTY, LLC in the amount of ONE HUNDRED EIGHTY THOUSAND and 00/100ths (\$180,000.00) DOLLARS, which sum the said R. REALTY, LLC offered to credit on the indebtedness secured by said mortgage, and said property was thereupon sold to the said R. REALTY, LLC ; and

WHEREAS, said mortgage expressly authorized the mortgagee to bid at the said sale and purchase said property, if the highest bidder therefor, and authorized the Mortgagee or Auctioneer or any person conducting said sale for the Mortgagee to execute to the purchaser at the said sale a deed to the property so purchased;
