WARRANTY DEED

} Know All Men by These Presents,

Shelby County

That in consideration of the sum of **One Hundred Fifty Two Thousand Dollars and No Cents (\$152,000.00)** to the undersigned grantor or grantors in hand paid by the GRANTEES herein, the receipt whereof is acknowledged, we, **Clifford T. Kelso and Dorothy B. Kelso, husband and wife** (herein referred to as grantors), do grant, bargain, sell and convey unto **Samuel Dabbs and Melanie R. Dabbs** (herein referred to as GRANTEES) as joint tenants with right of survivorship, the following described real estate situated in Shelby, County, Alabama, to wit:

Lot 2-A, according to the Resurvey of Lot 2 of Faulkner Estates, as recorded in Map Book 27, Page 17, in the Office of the Judge of Probate of Shelby County, Alabama; being situated in Shelby County, Alabama.

Subject to easements, reservations and restrictions at record.

The grantor, Clifford T. Kelso is one and the same person as Clifford D. Kelso, the grantee named in Instrument# 20050701000329430, recorded in the Probate Office of Shelby County, Alabama.

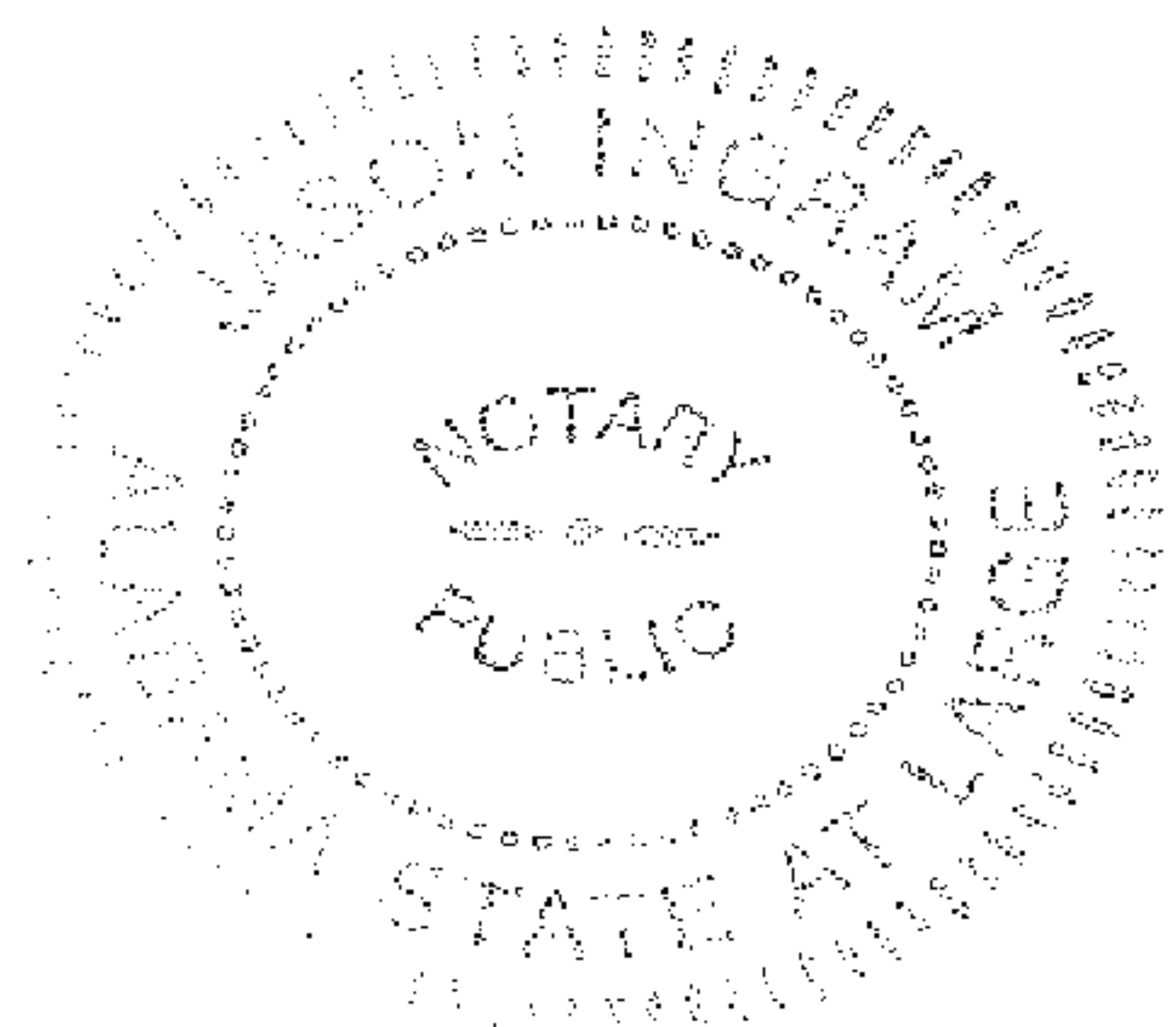
