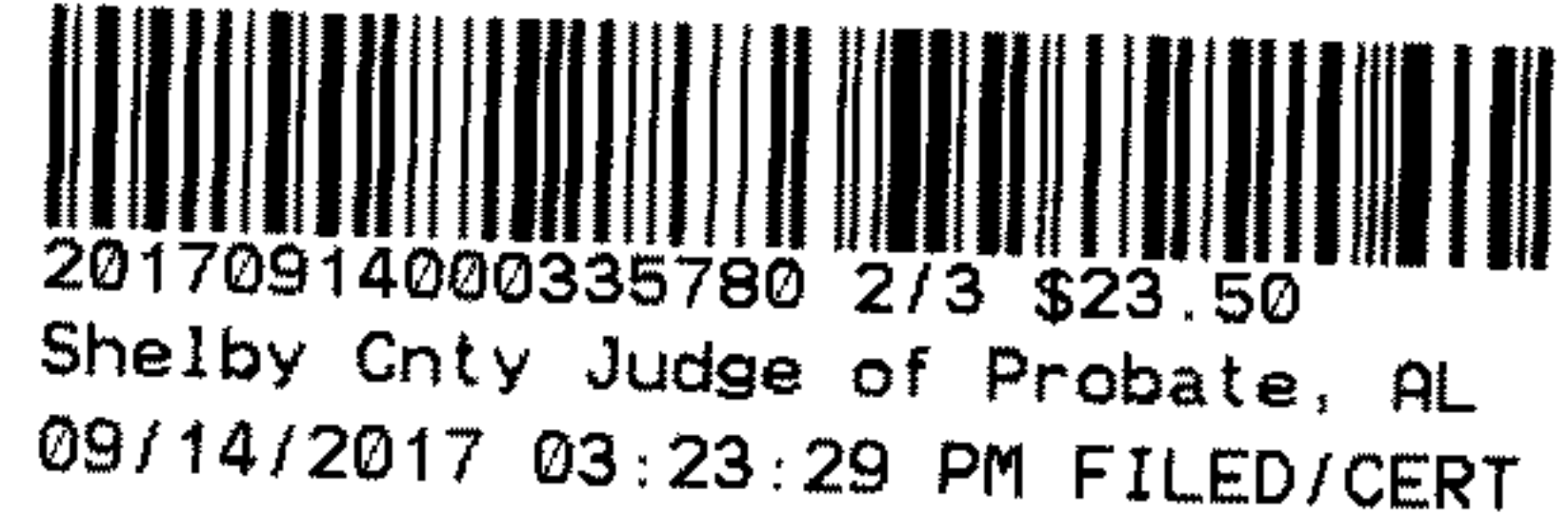
The above described property is not the homestead of GRANTOR or his/her spouse(s).

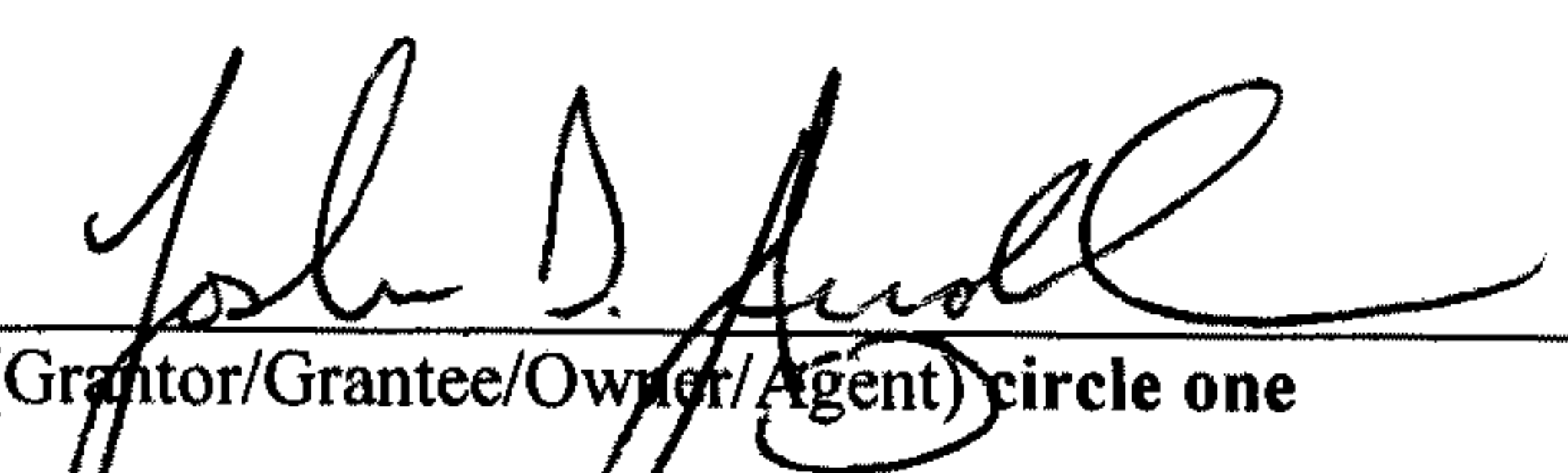
