KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 5th day of November, 2015, Lewis A. Porter and Shirley B. Porter, husband and wife, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for TJC Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20151109000388250, said mortgage having subsequently been transferred and assigned to Pingora Loan Servicing, LLC, by instrument recorded in Instrument Number 20170619000217670, in the aforesaid Probate Office ("Transferee"); and

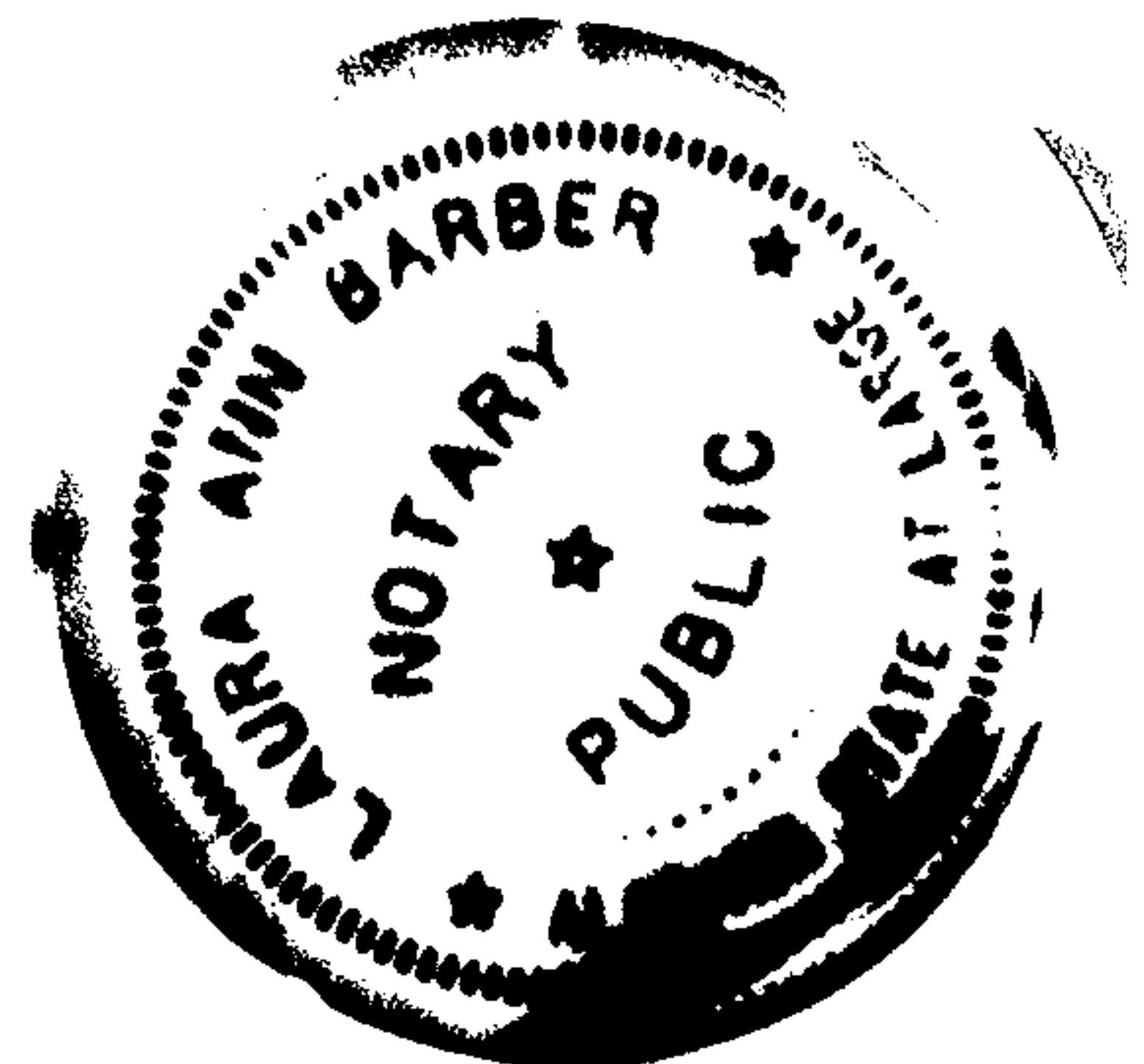

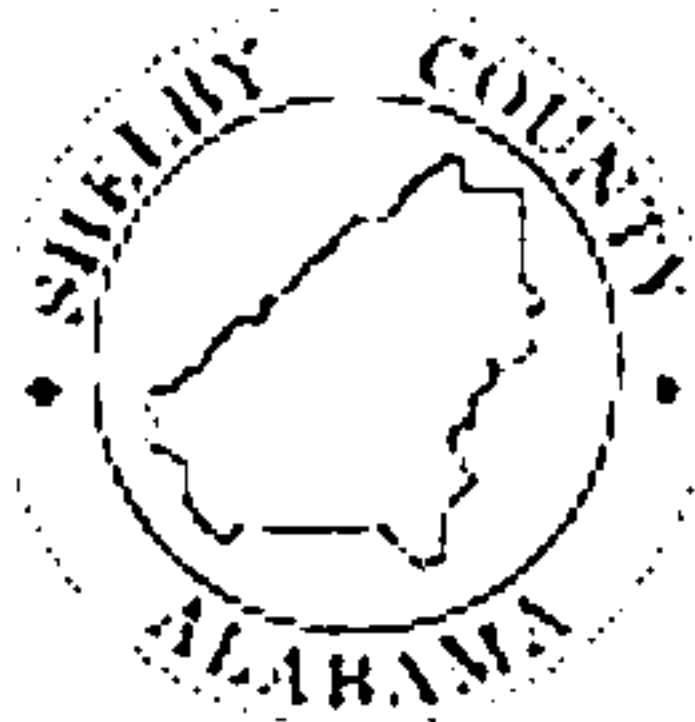
