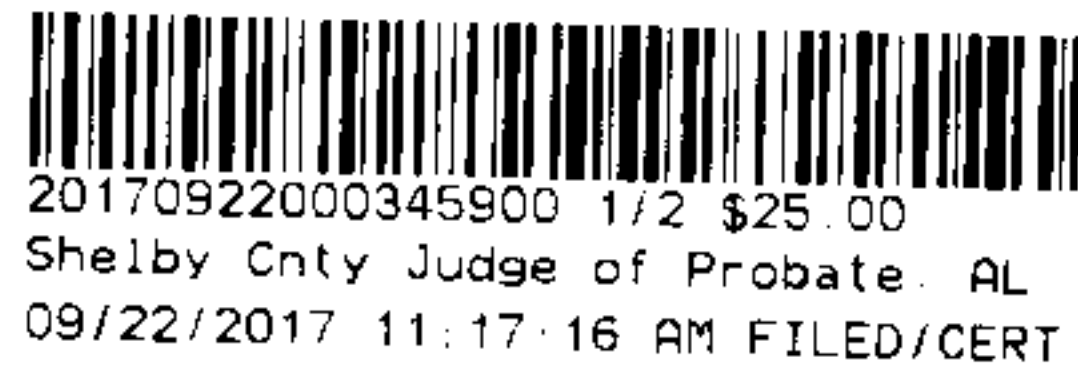

KNOW ALL MEN BY THESE PRESENTS, That in consideration of **FIVE THOUSAND DOLLARS AND ZERO CENTS (\$5,000.00)**, and other good and valuable considerations to the undersigned grantor, in hand paid by grantee herein, the receipt whereof is acknowledged, I or we, **Robert E. Owens, a married man** (herein referred to as **Grantors**), grant, bargain, sell and convey unto, **Larry W. Owens, Robert E. Owens, Kathy Handley and Kathleen Perkins** (herein referred to as **Grantee**), the following described real estate, situated in: SHELBY County, Alabama, to-wit:

Lot 575, according to the Survey of Waterford Highlands, Sector 4, Phase 1, as recorded in Map Book 34, Page 73, in the Probate Office of Shelby County, Alabama.

SUBJECT TO:

3. Ad valorem taxes due and payable October 1, 2017.

No part of the homestead of the Grantor herein or his spouse.

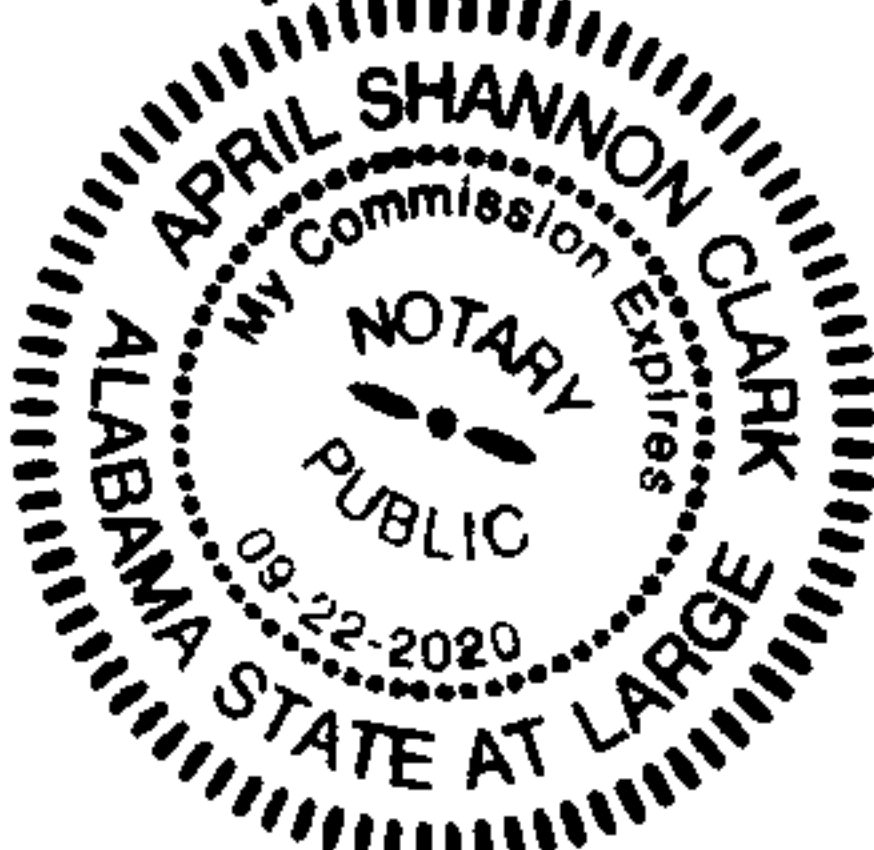
