Owens, a married man** (herein referred to as **Grantors**), grant, bargain, sell and convey unto, **Larry W. Owens, Robert E. Owens, Kathy Handley and Kathleen Perkins** (herein referred to as **Grantee**), the following described real estate, situated in: SHELBY County, Alabama, to-wit:

Lot 79, according to the Resurvey of Final Plat of High Ridge Village, Phase 4, as recorded in Map Book 29, page 83, in the Probate Office of Shelby County, Alabama.

SUBJECT TO:


