KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 24th day of June, 2015, Alexander Compas, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for LoanDepot.Com, LLC, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20150710000232880, said mortgage having subsequently been transferred and assigned to Pingora Loan Servicing, LLC, by instrument recorded in Instrument No. 20170316000088220, in the aforesaid Probate Office ("Transferee"); and

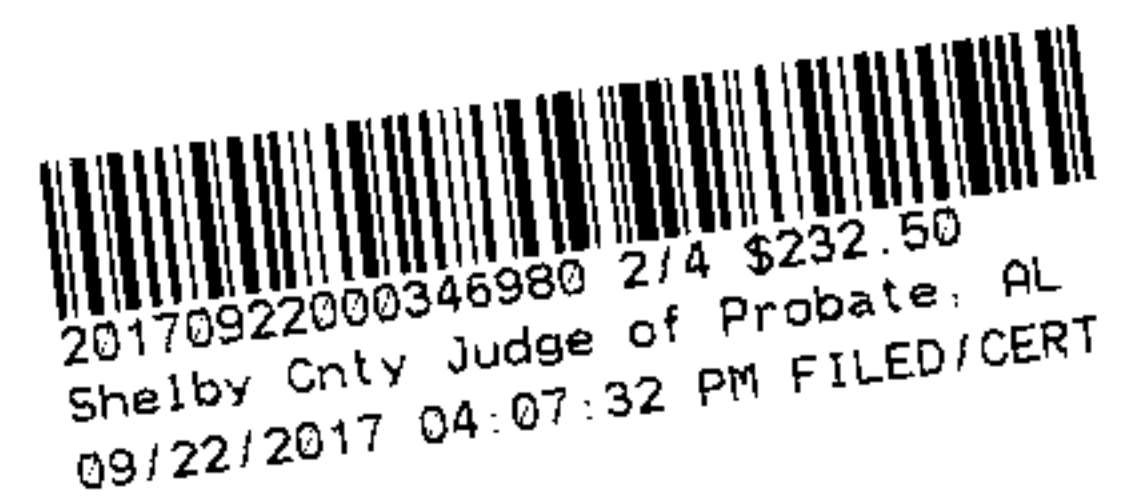

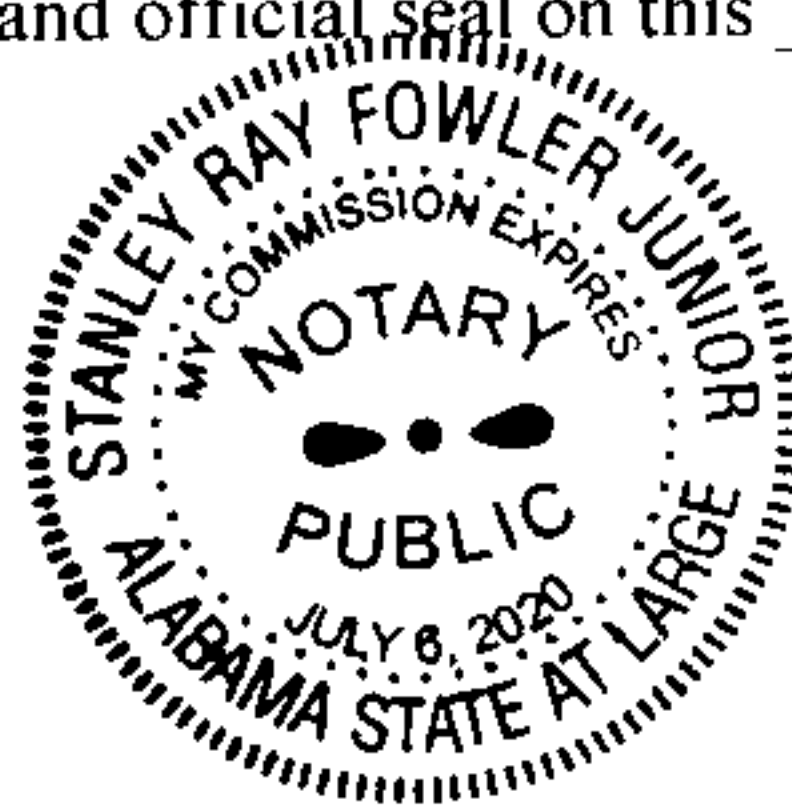
