SPECIAL WARRANTY DEED

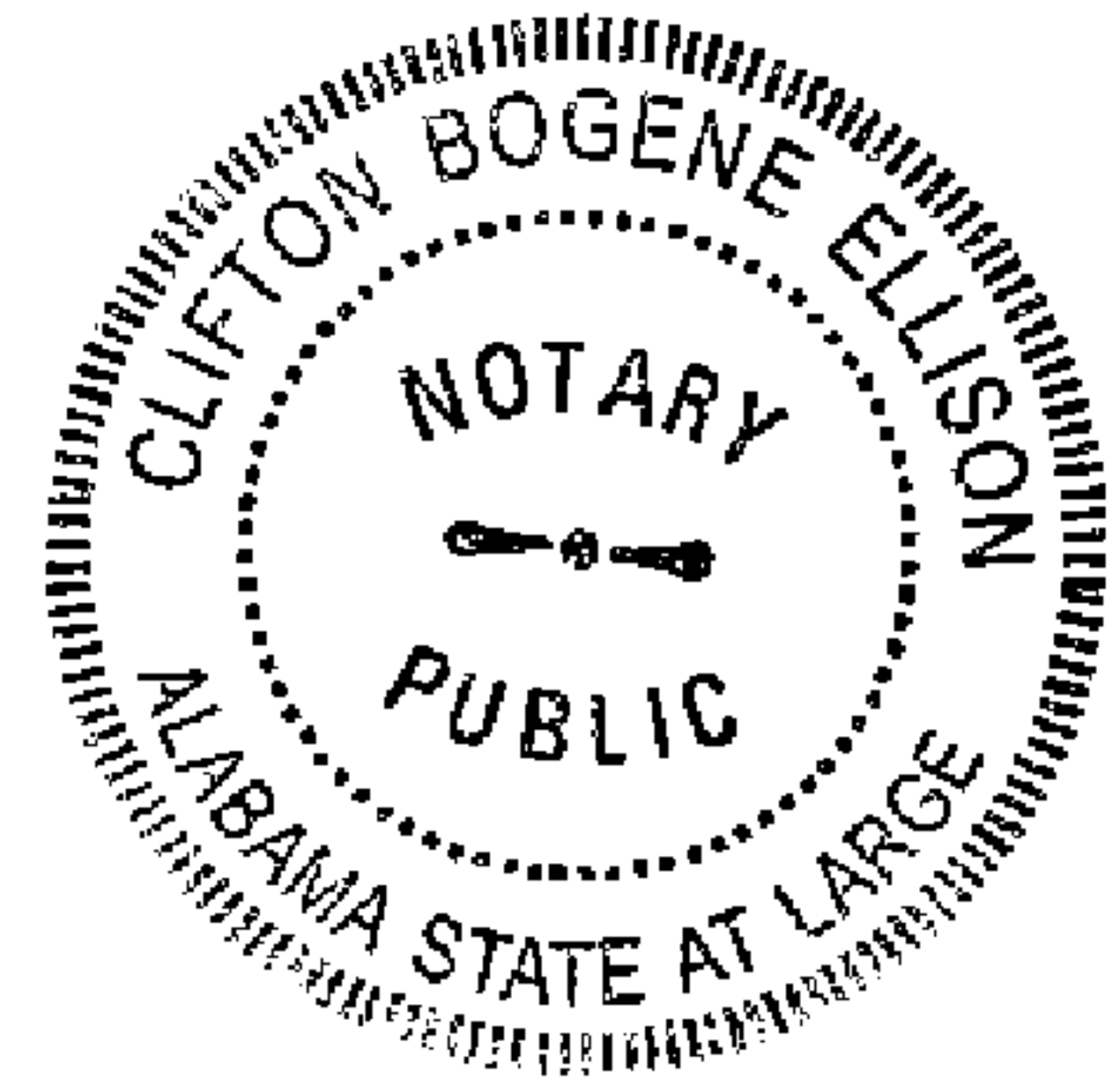
