The Lien Claimant satisfactorily completed and fulfilled its obligation CLEAN WATER RESTORATION SERVICES in the aforementioned Premises on 09/25/17, and the Owner having inspected and approved of the work completed. To date the Lien Claimant has received a down payment toward the project build in the amount of \$0, thus leaving a balance due of \$3290.15.

Lien Claimant, in good faith, provided the agreed upon labor and materials needed to CLEAN WATER RESTORATION SERVICE at the request of the Owner of the Premise. A final invoice was provided to the Owner itemizing cost of materials and labor

with a request for final payment. Furthermore, 4 months have elapsed since the Owner was provided with the final balance due.

The Lien Claimant hereby states and affirms that there is a total outstanding balance of \$3290.15

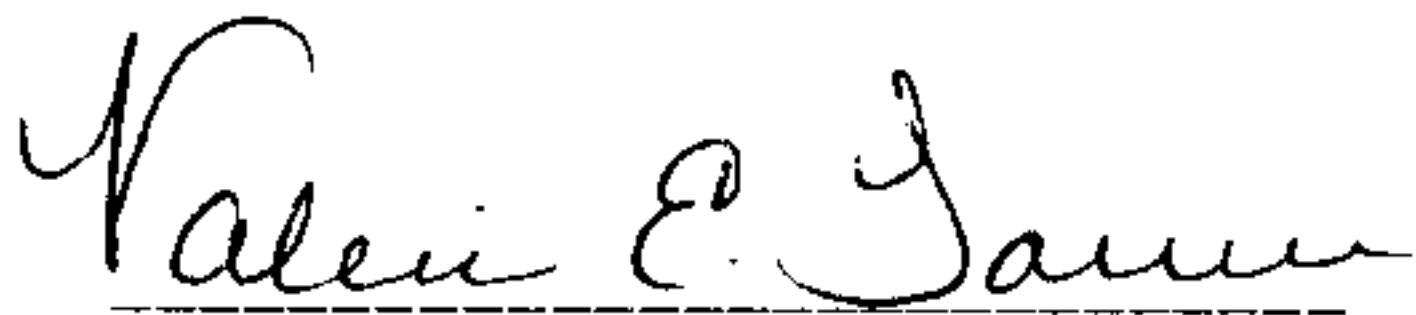
