That in consideration of the sum of **One Hundred Ninety Nine Thousand Dollars and No Cents (\$199,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Orville Guin Piper, Jr. and Rita G. Piper, Husband and wife** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Justin Andrew Clark and Kelsi McNeill Clark**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;




