This deed is executed as a corrective document. Correcting the title into the Grantee herein.

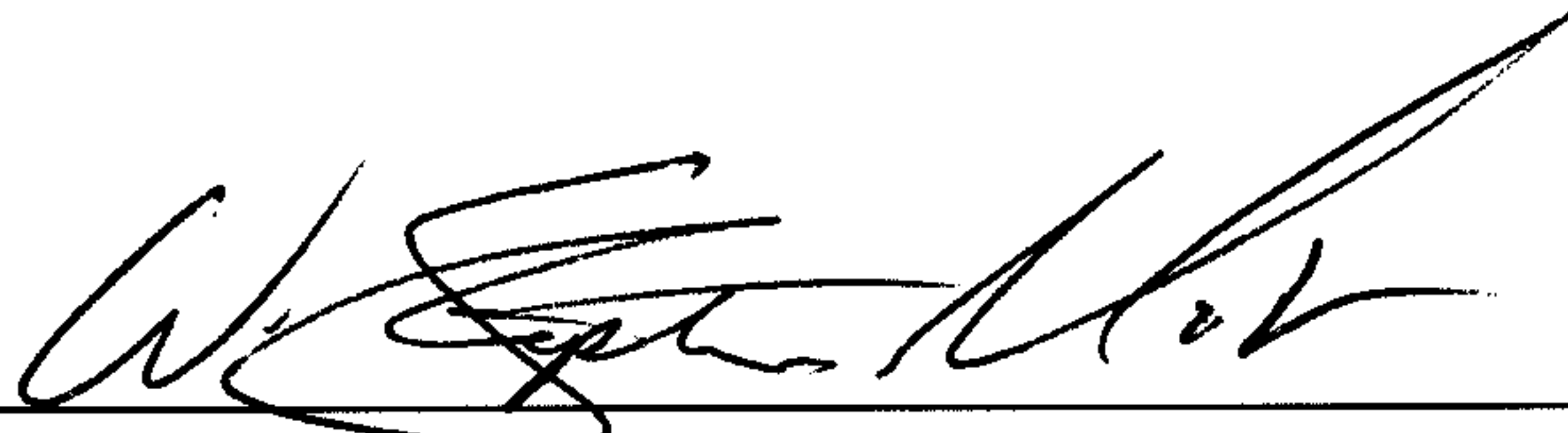
The above described property constitutes no part of the homestead of the Grantor.

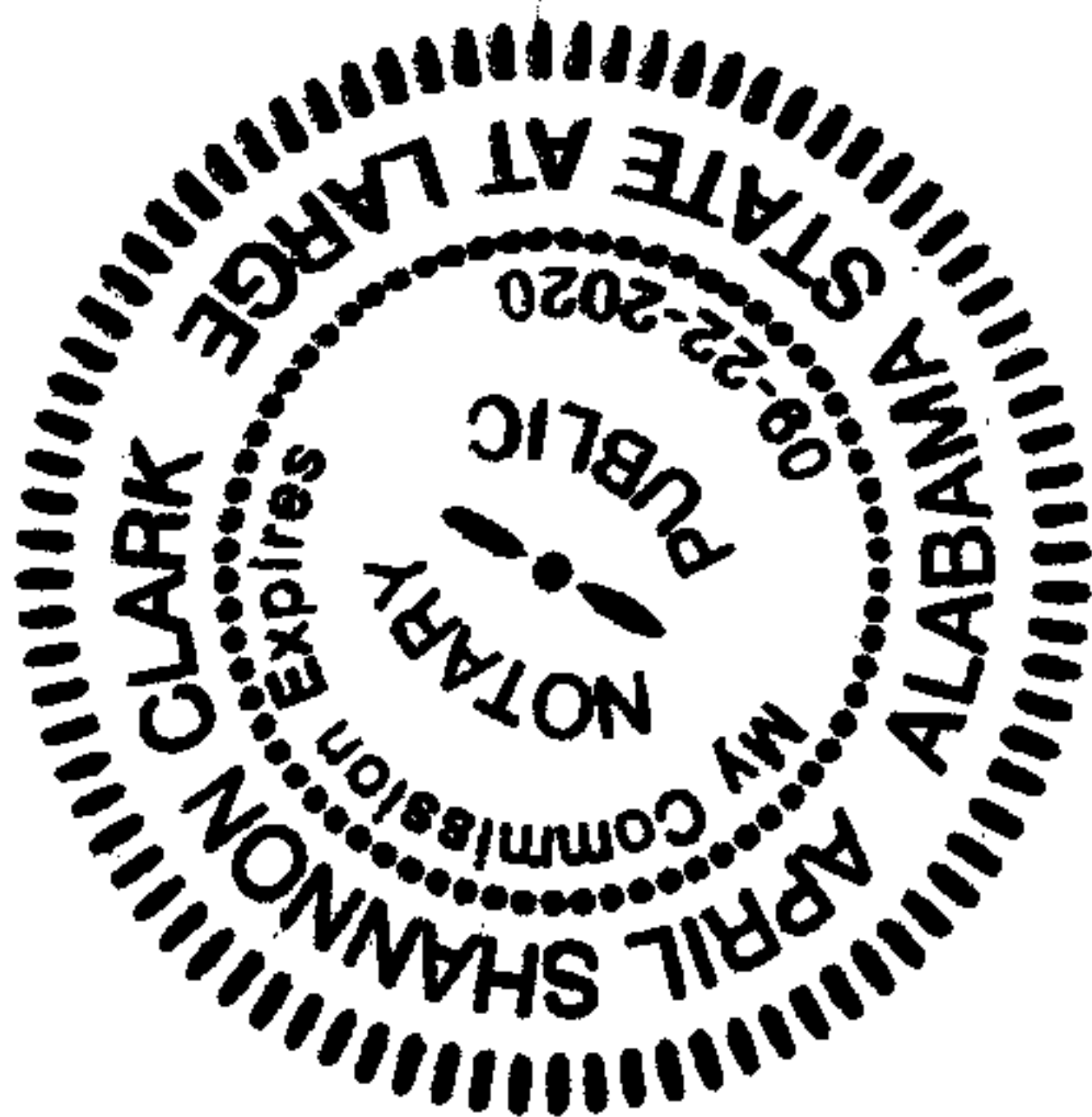


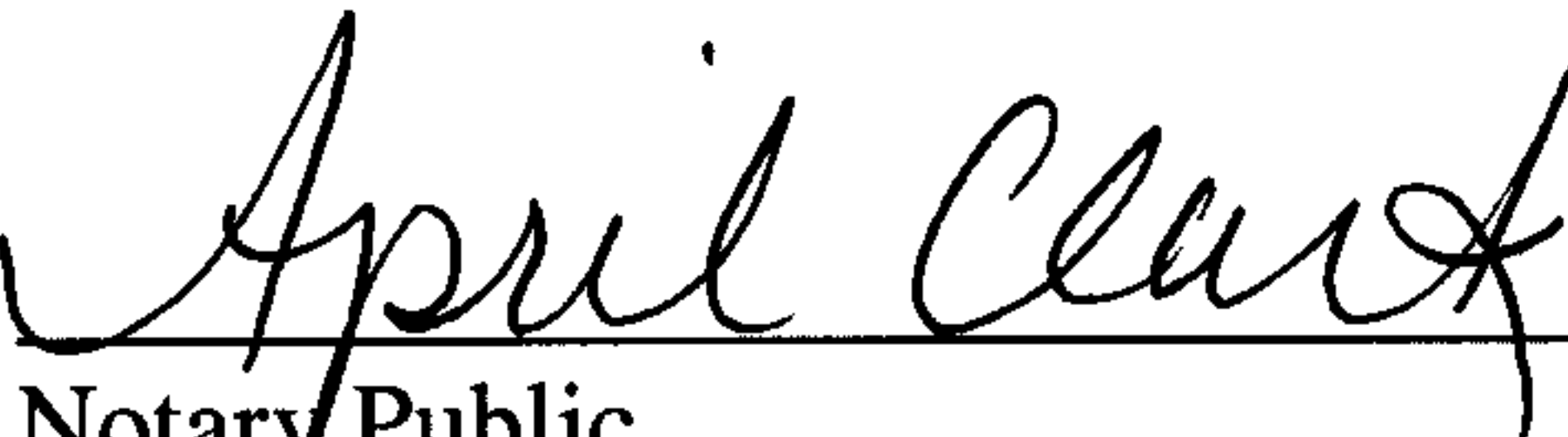

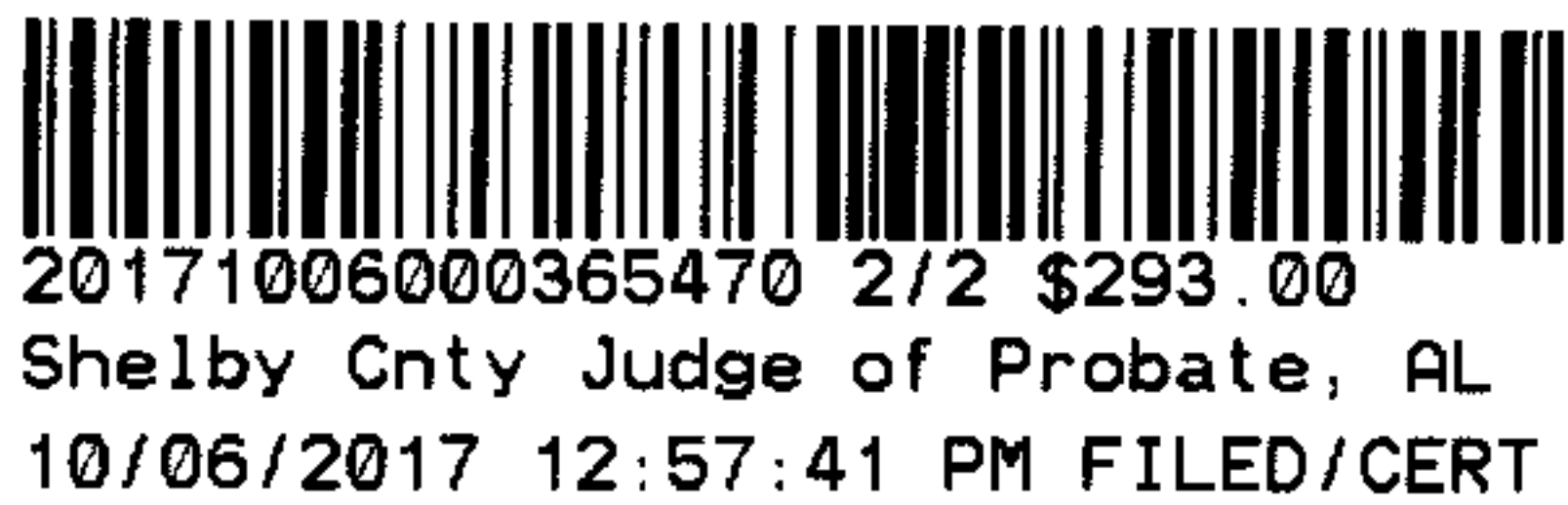
