WARRANTY DEED, JOINT TENANTS WITH RIGHT OF SURVIVORSHIP

(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Brenda K. Davis and Edgar E. Davis, Jr.

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 23, according to the Survey of Old Town Helena, as recorded in Map Book 22, Page 26, in the Probate Office of Shelby County, Alabama.



\$130,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.

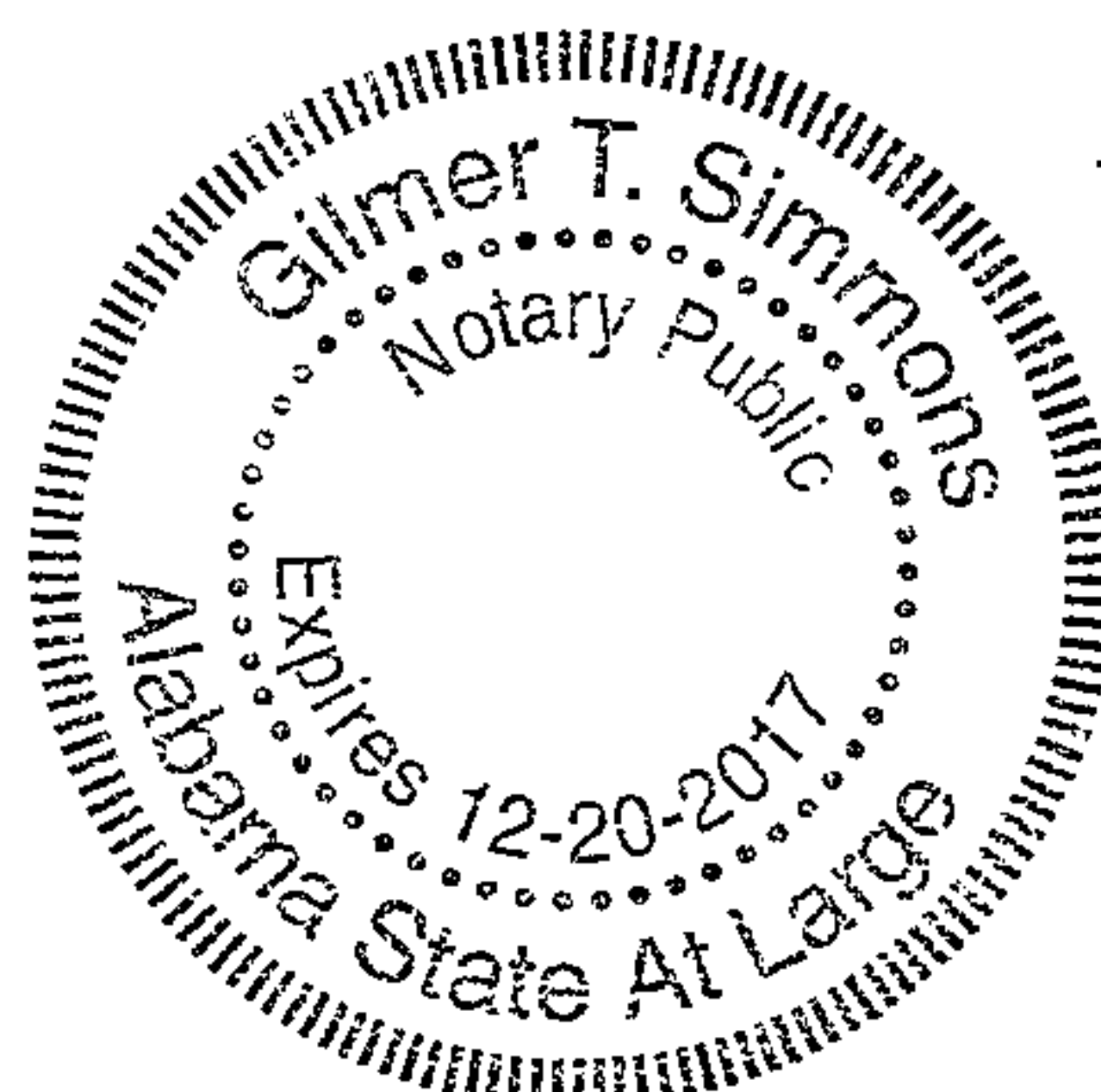

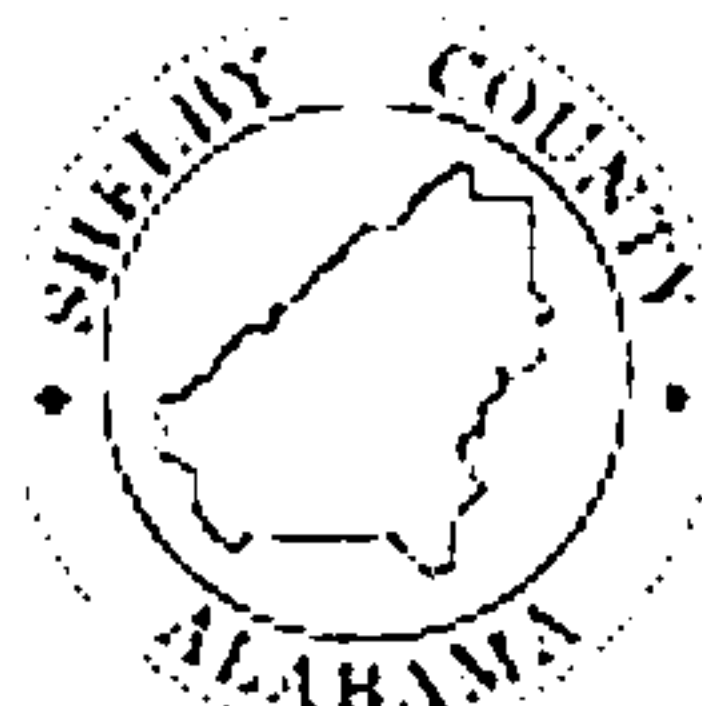
