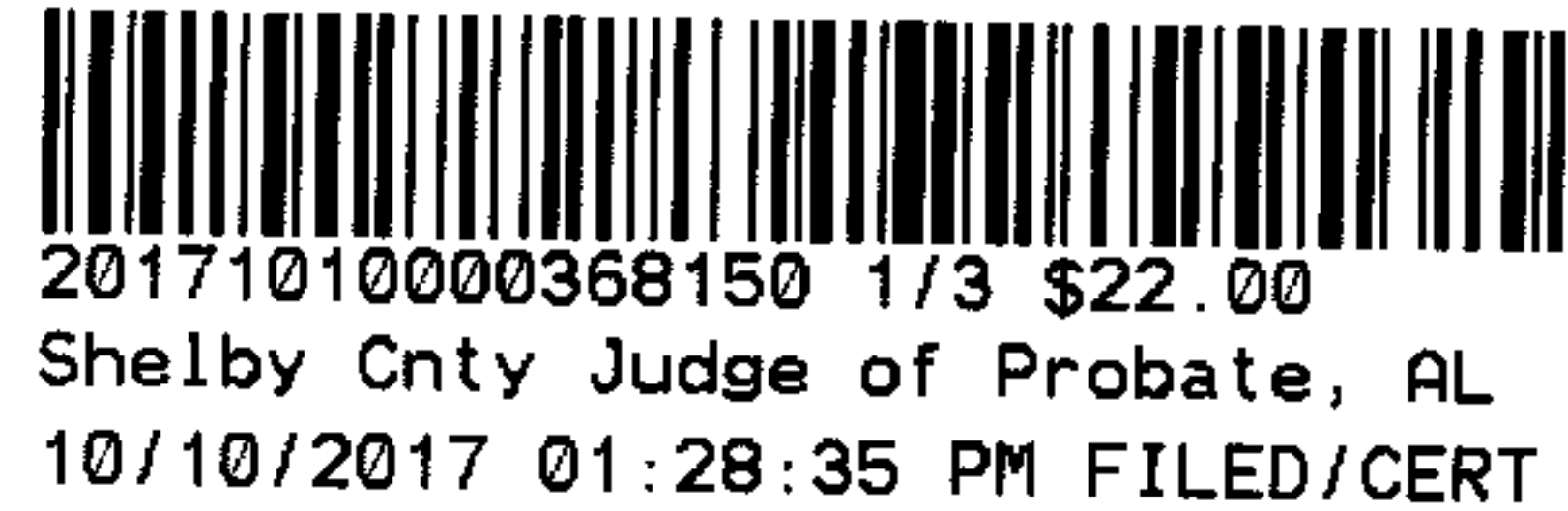

Subject to Easements, Restrictions and rights of way of record.

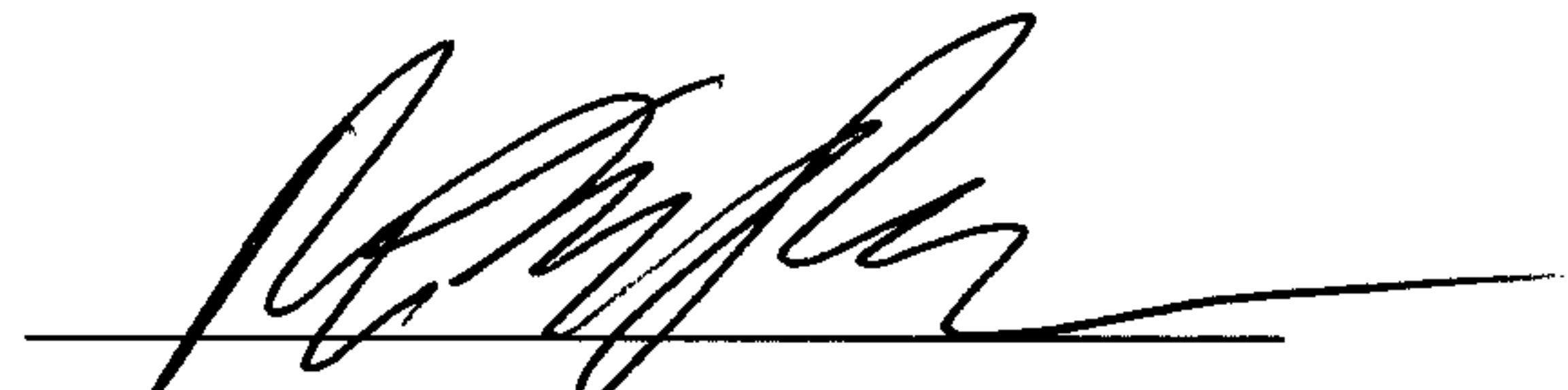

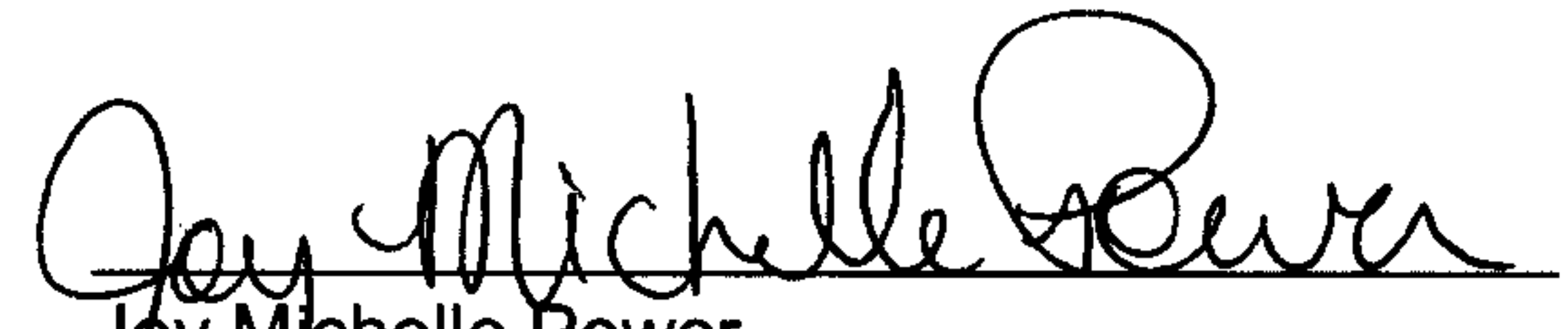
\$420,800.00 of the purchase price was obtained by a purchase money mortgage filed simultaneously herewith

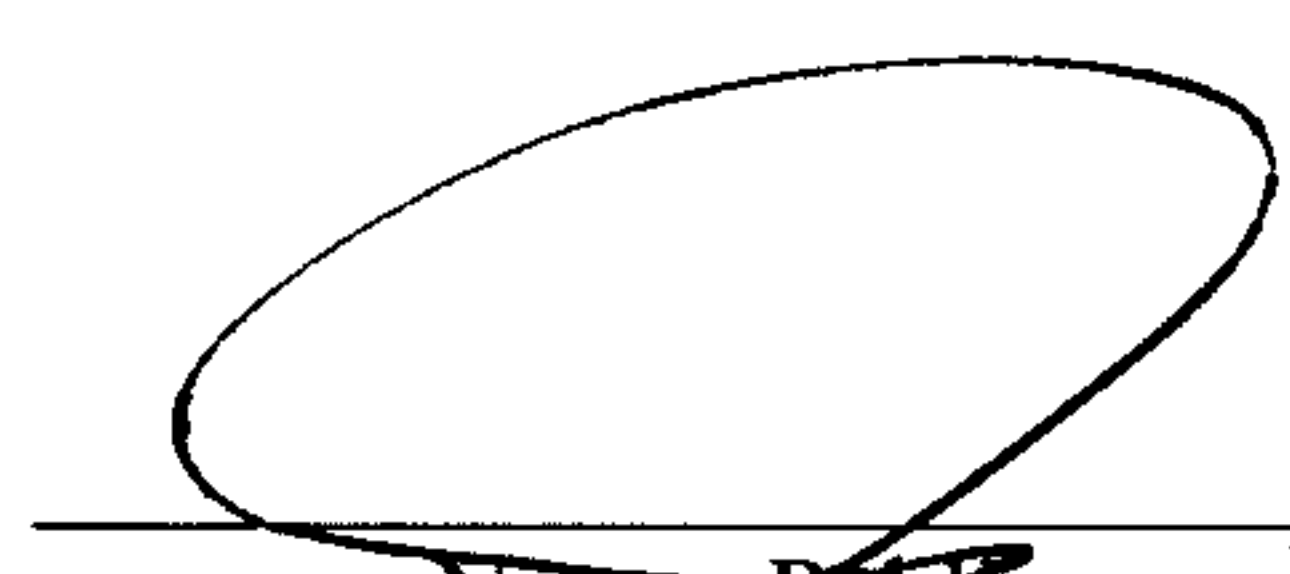
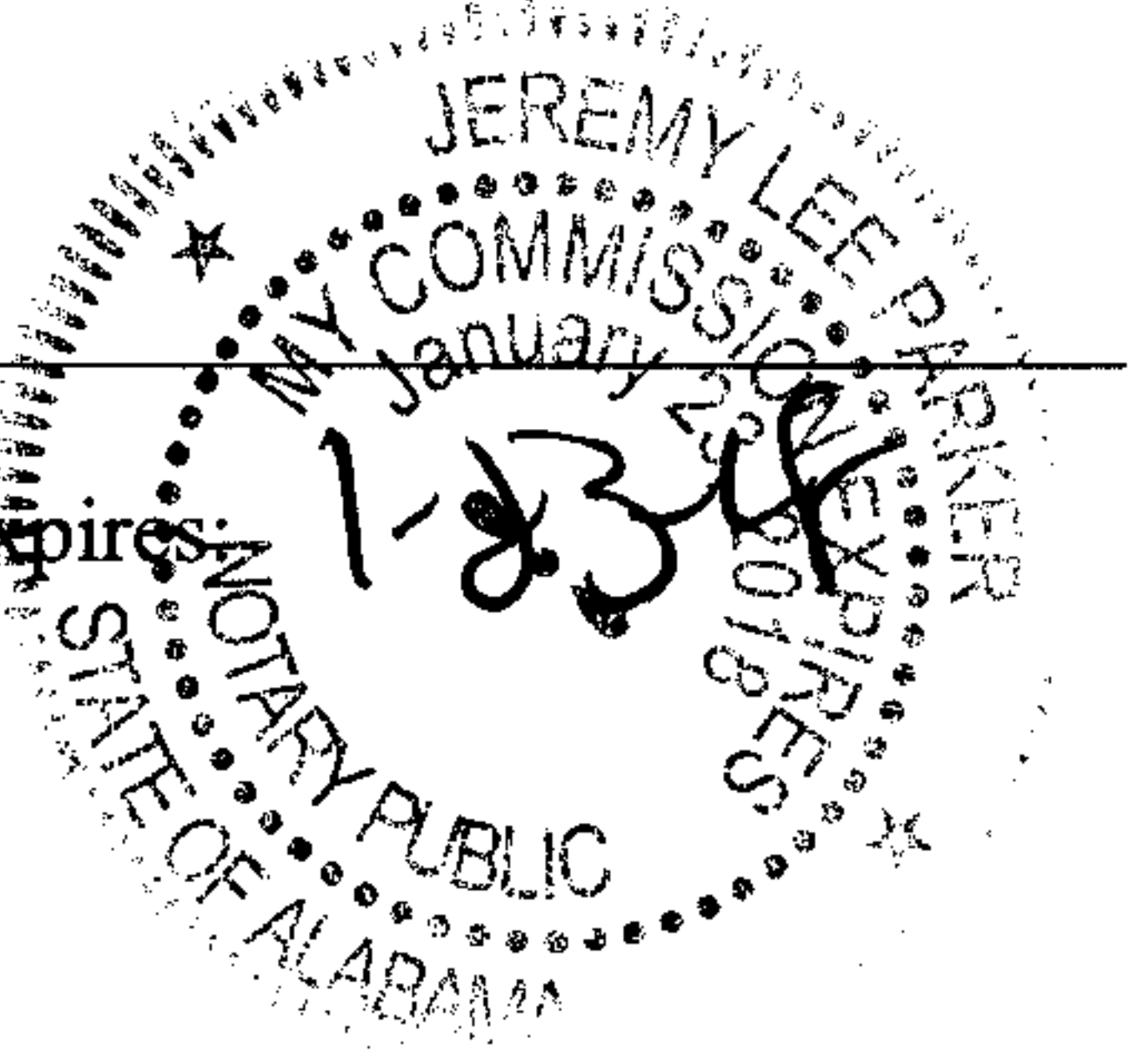
