FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 27th day of July, 2013, Jonathan H. Crawford, Jr., a single man, executed that certain mortgage on real property hereinafter described to Quicken Loans Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20130812000326860, said mortgage having subsequently been transferred and assigned to Ditech Financial LLC, by instrument recorded in Instrument Number 20170721000260700, in the aforesaid Probate Office ("Transferee"); and
