That in consideration of the sum of **One Hundred Forty Thousand Dollars and No Cents (\$140,000.00)**, the amount of which can be verified in the Sales Contract between the parties hereto, to the undersigned Grantor (whether one or more), in hand paid by the Grantee herein, the receipt whereof is acknowledged, I or we, **Christopher C. Williamson and Susan H. Williamson, husband and wife** (herein referred to as Grantor, whether one or more), grant, bargain, sell and convey unto **Gary Martin and Kelly Martin**, (herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby, County, Alabama, to wit;

Situated in Shelby County, Alabama.

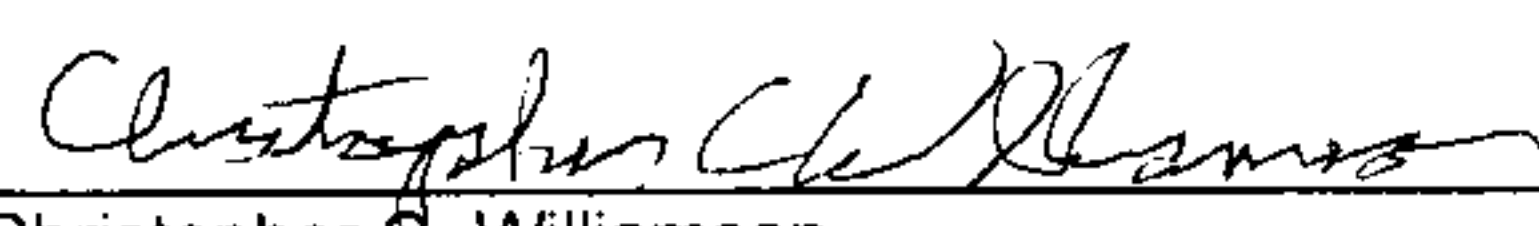
