Lot 1315, as recorded in Map Book 22, Page 23, Shelby County, Alabama records

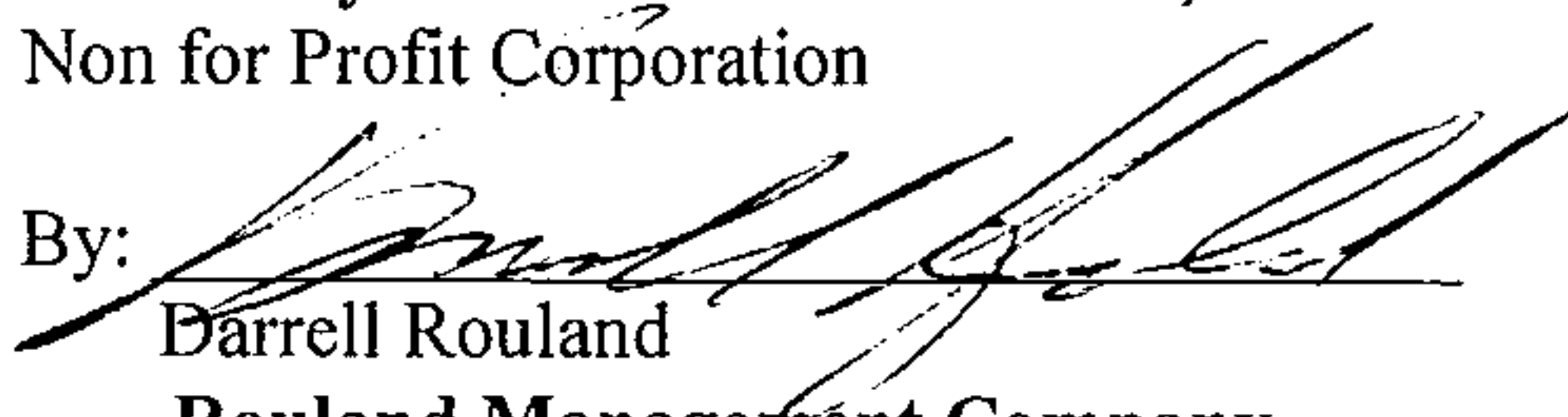

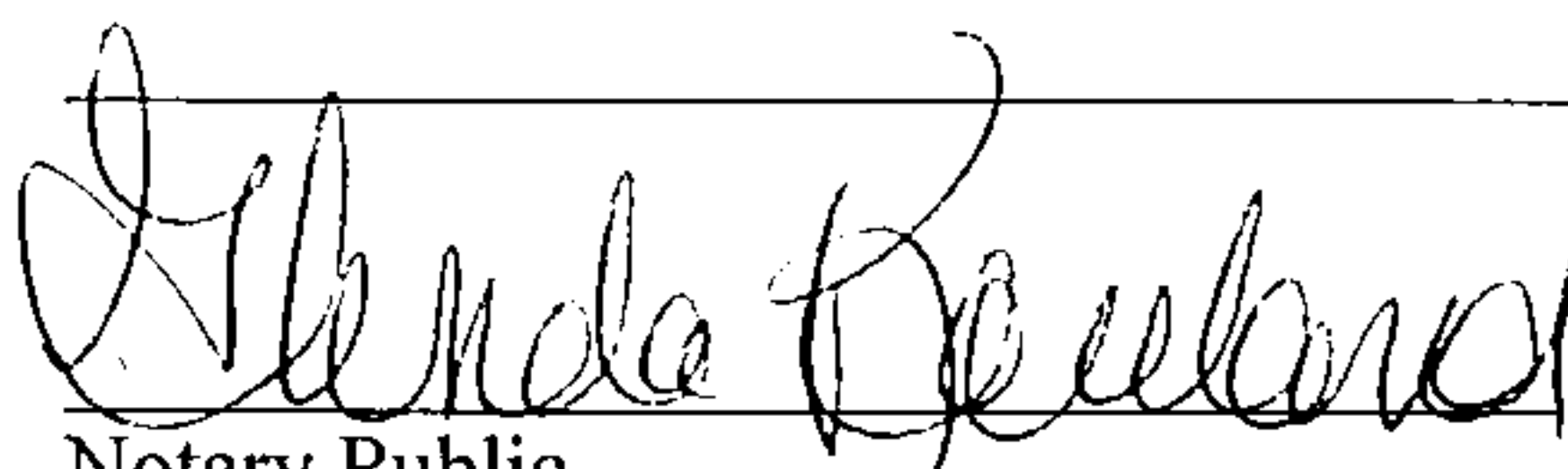
