The Association claims a lien upon property owned by **Justin Alexander** situated in Shelby County, Alabama described as follows:



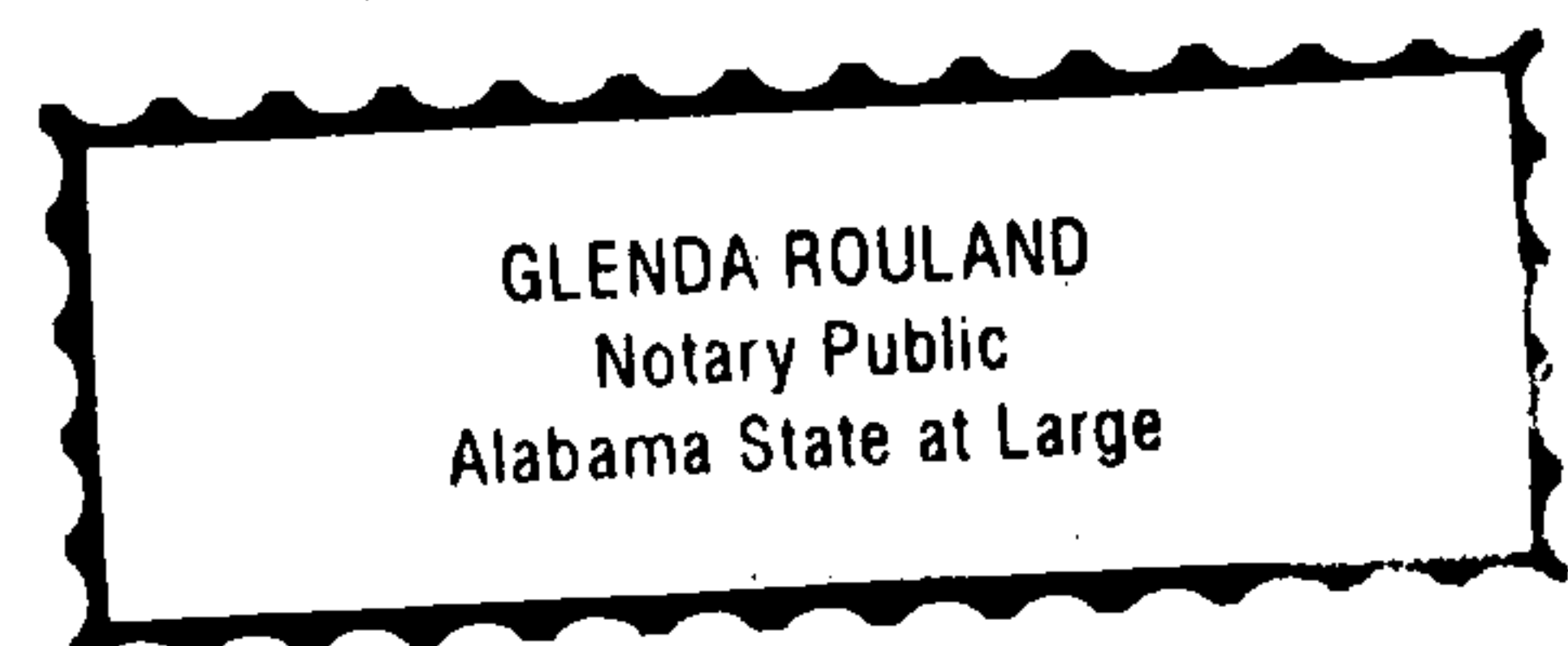
