The Association claims a lien upon property owned by **Tuscacal, LLC** situated in Shelby County, Alabama described as follows:

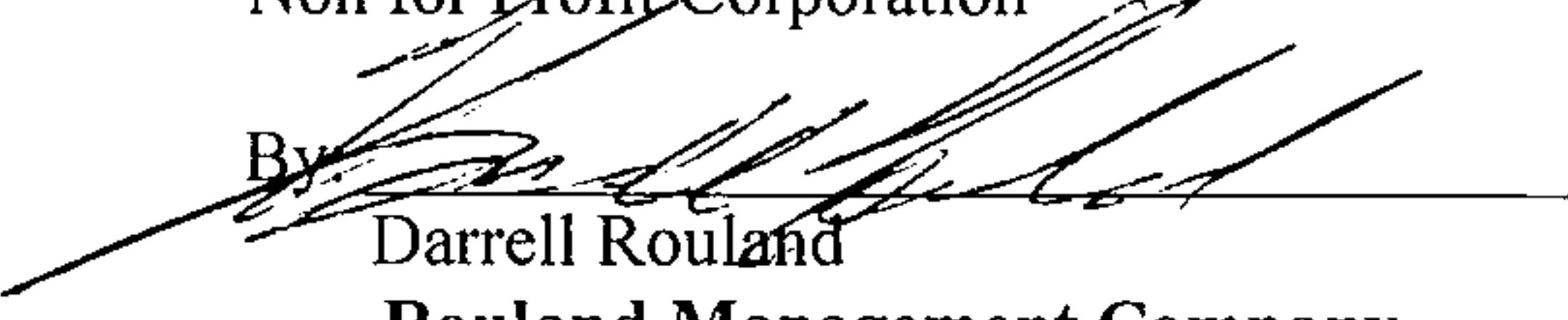

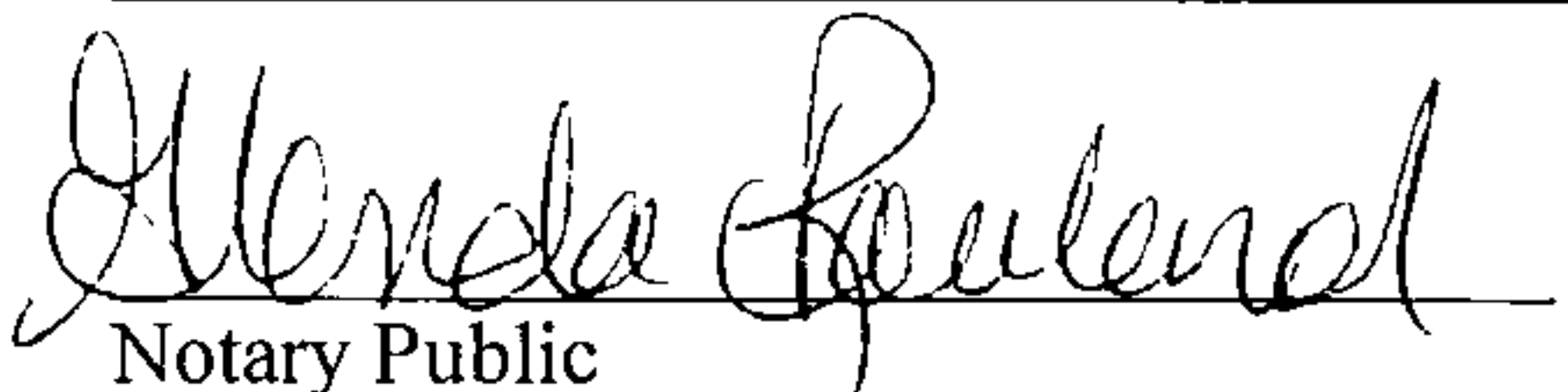

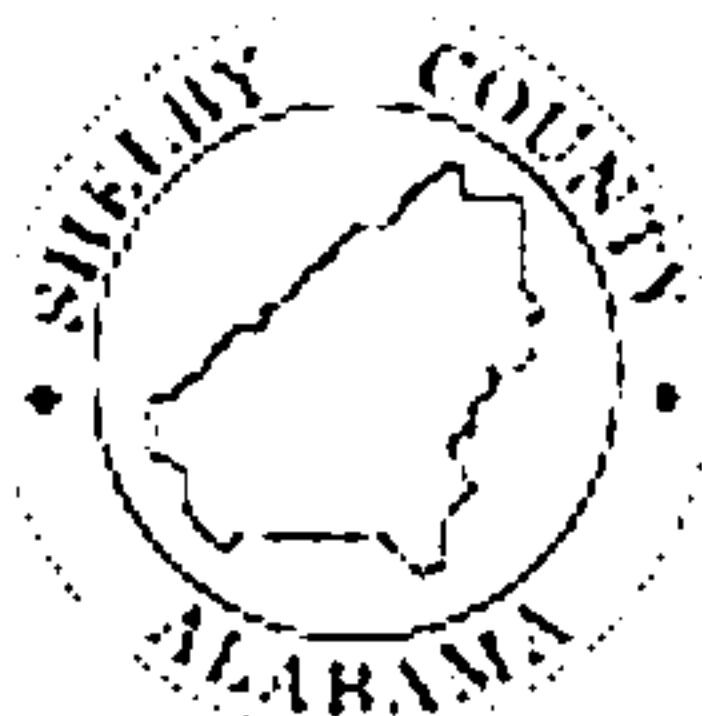
