The Association claims a lien upon property owned by **John Brock Gilbert** situated in Shelby County, Alabama described as follows:

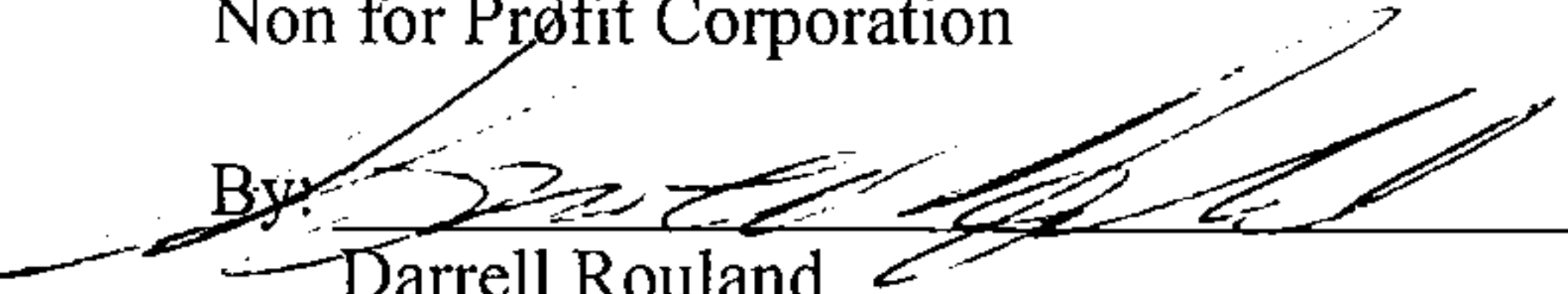

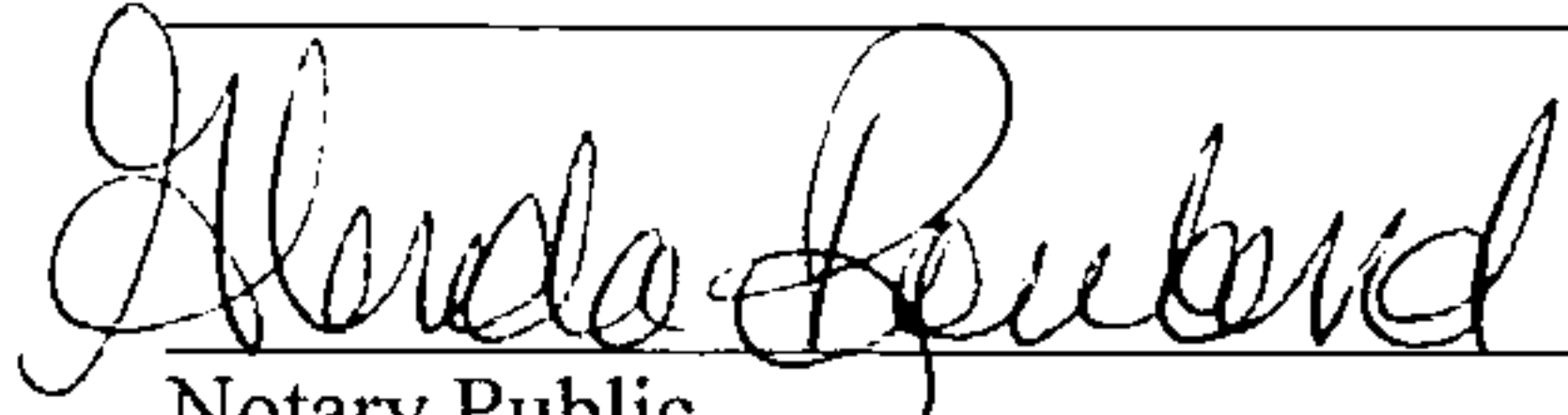
