The Association claims a lien upon property owned by Lisa J. Hosmer-Portera & Tim Glasgow situated in Shelby County, Alabama described as follows:

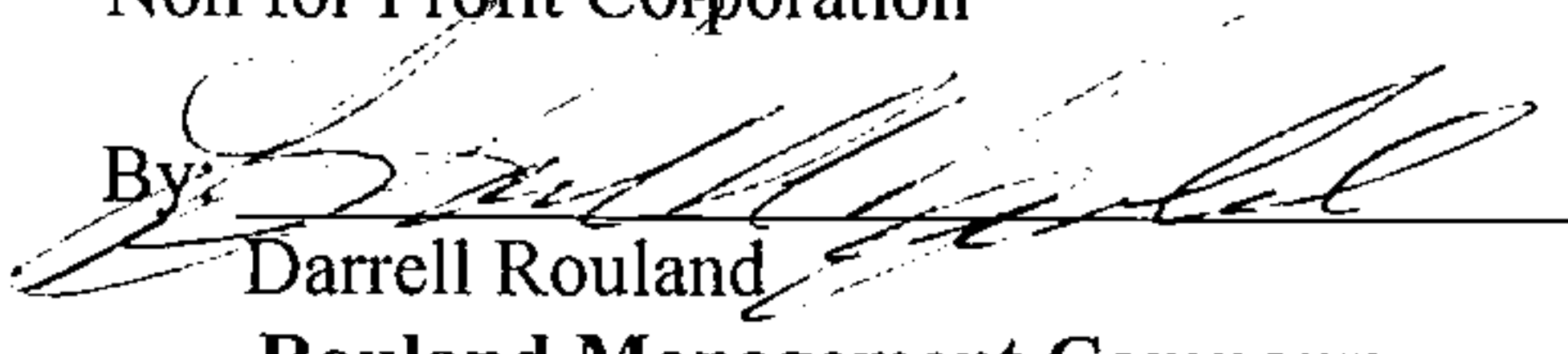

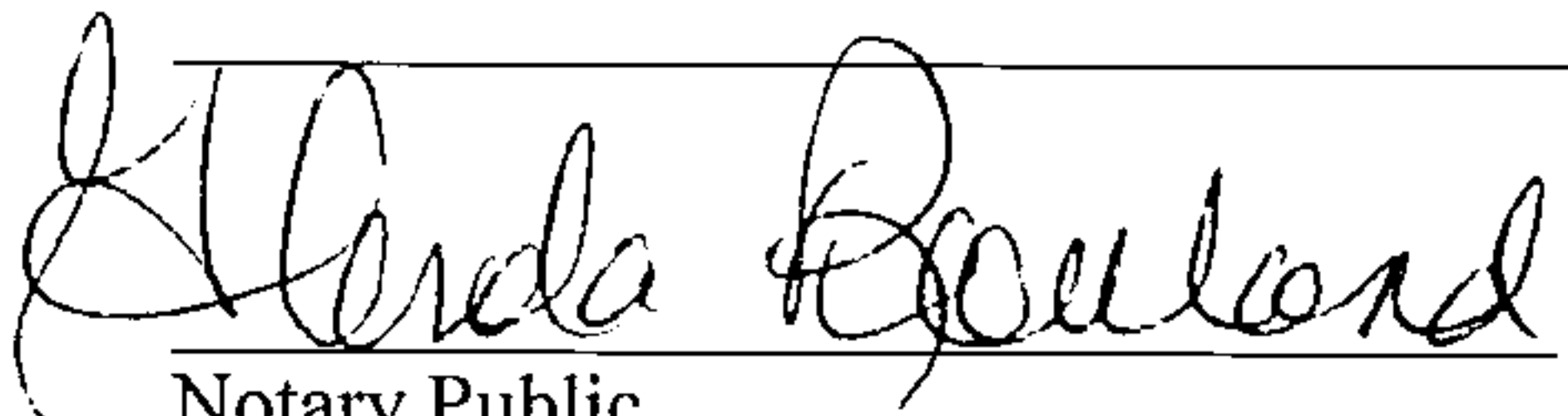
