FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on May 29, 2009, to-wit: Jacqueline B. Moore, an unmarried woman, executed a mortgage to Mortgage Electronic Registration Systems, Inc., solely as nominee for Platinum Mortgage, Inc., A Alabama Corporation, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on June 18, 2009, in Instrument No. 20090618000234580, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to CitiMortgage, Inc., by assignment recorded September 9, 2016, in Instrument No. 20160909000327300, Probate Records of Shelby County, Alabama; and

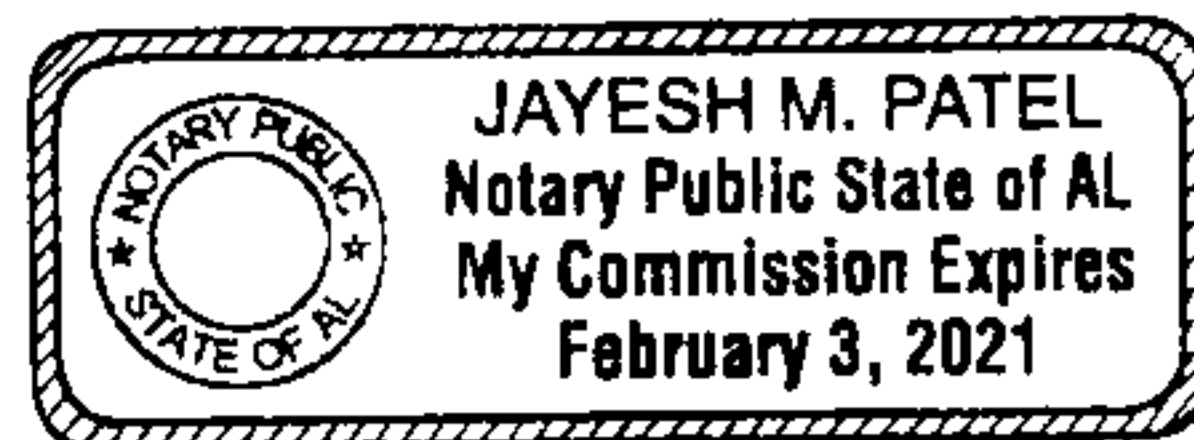
