**GENERAL WARRANTY DEED
With Right of Survivorship**

STATE OF ALABAMA }

COUNTY OF SHELBY } KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **Three Hundred Twenty-Nine Thousand Nine Hundred Dollars and NO/100 (\$329,900.00)** to the undersigned grantor, in hand paid by the Grantees herein, the receipt whereof is acknowledged, I, **Cornerstone Building, LLC**, (herein referred to as **Grantor**), grant, sell, bargain and convey unto, **James H. Harrison, Jr and Teresa B. Harrison** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

Lot 1A, according to the Resurvey of Lot 1 of Chelsea Ridge Estates, 1st Sector and Acreage, as recorded in Map Book 46, Page 49, in the Probate Office of Shelby County, Alabama.


Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

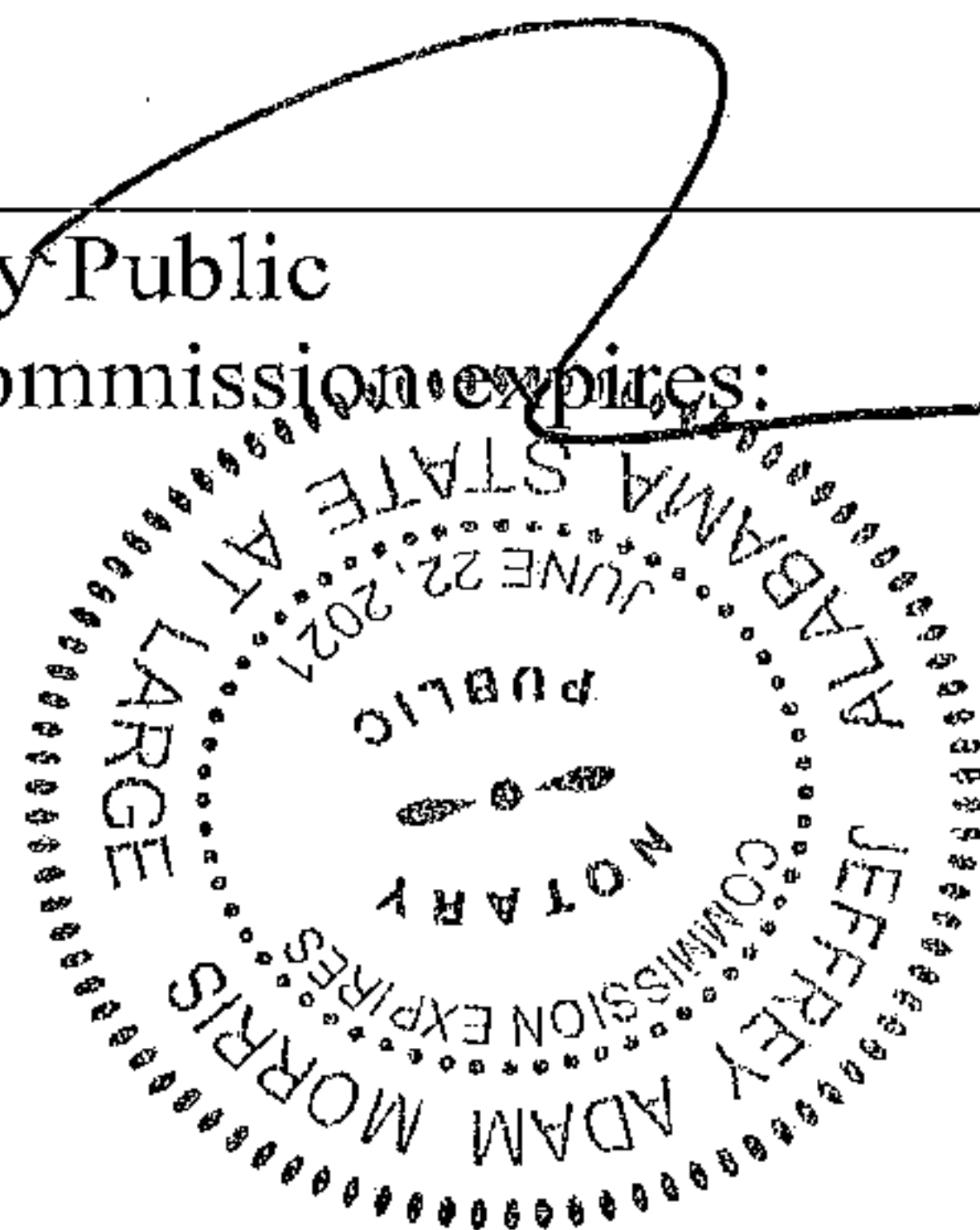
