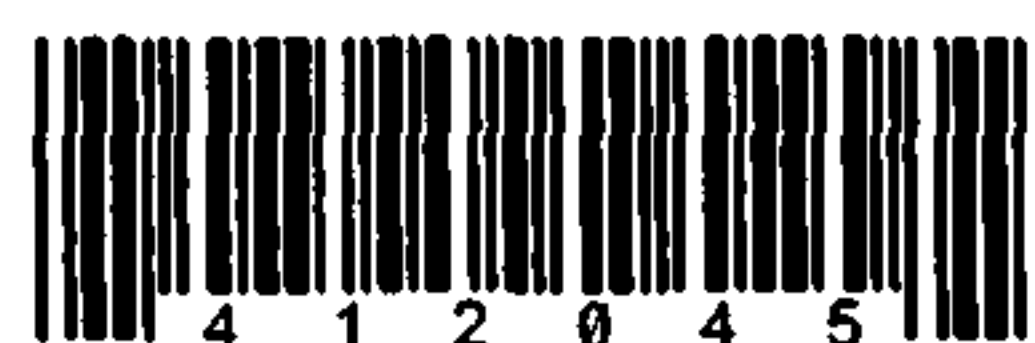
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 21st day of July, 2005, James E. Barnes and Virginia R. Bradshaw nka Virginia Barnes, husband and wife, executed that certain mortgage on real property hereinafter described to MorEquity, a DIV of AIG FSB, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20050729000381010, said mortgage having subsequently been transferred and assigned to U.S. Bank National Association, as Trustee for American General Mortgage Loan Trust 2010-1 American General Mortgage Pass-Through Certificates, Series 2010-1 , by instrument recorded in Instrument number 20170508000158740, in the aforesaid Probate Office ("Transferee"); and

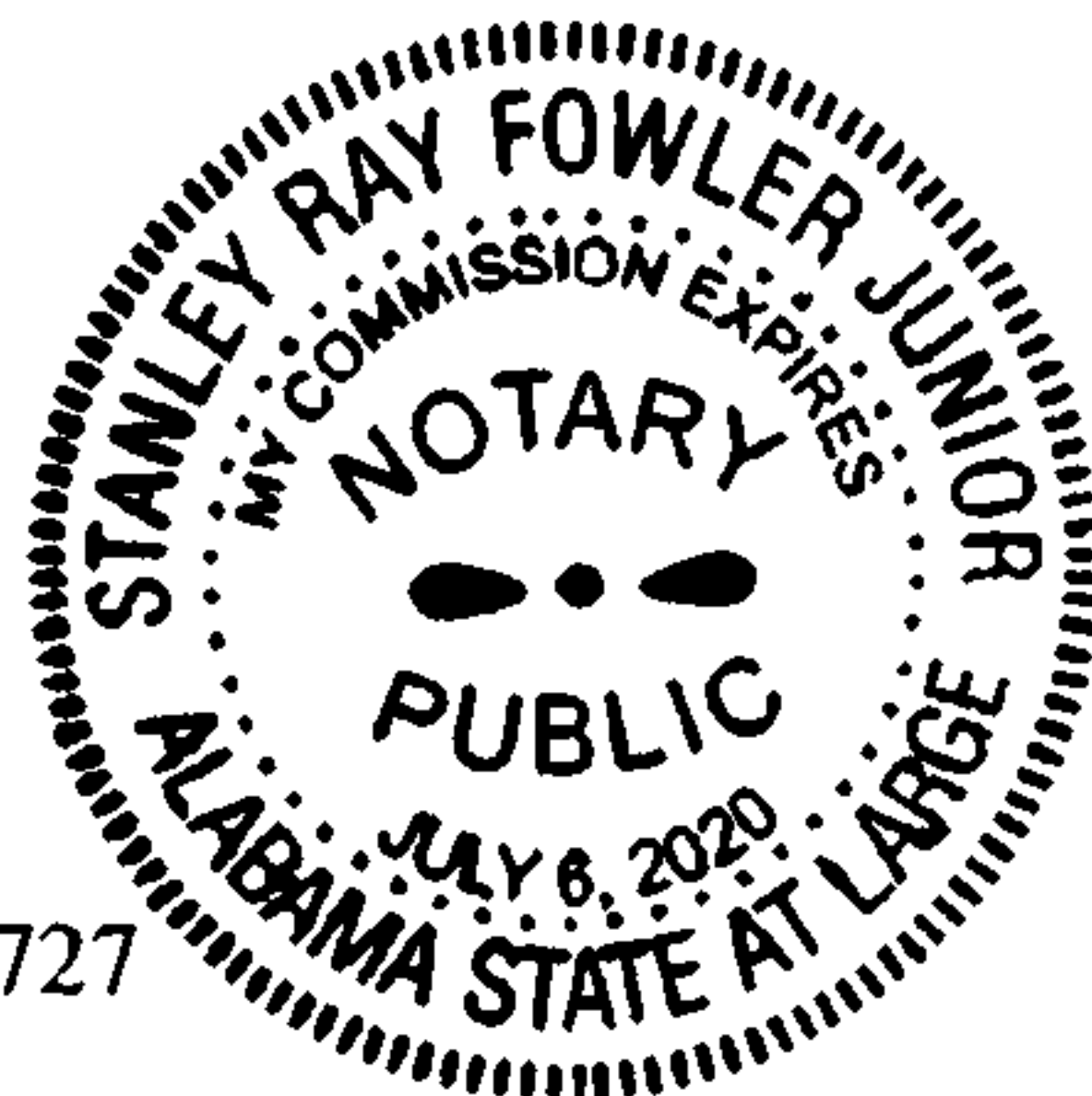
