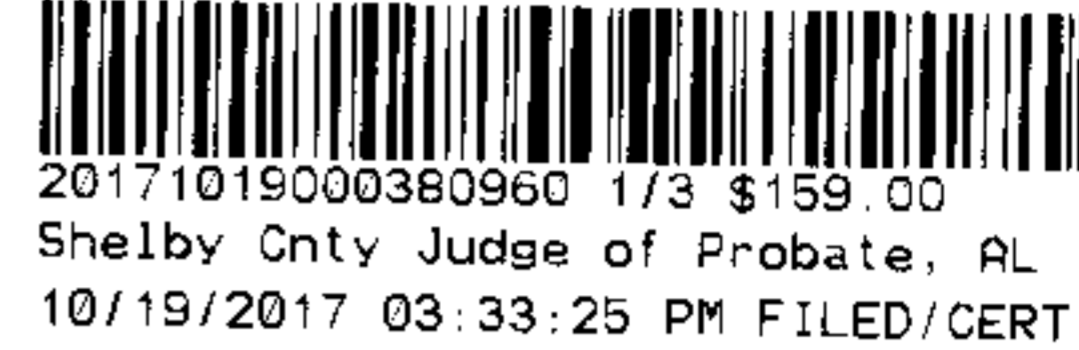


**ARTICLE OF ORGANIZATION

The remaining members shall have the right to continue the business after and event of dissociation terminates the continues membership of a member in the LLC.


ARTICLE IX
