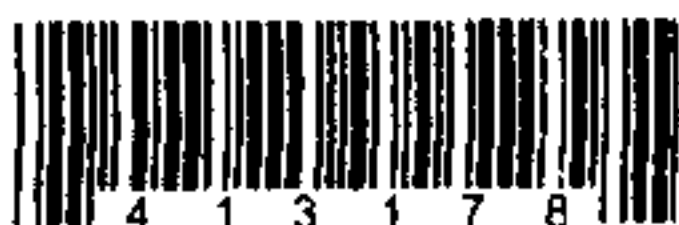

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 23rd day of June, 2006, Richard W. Jones Jr and Penny D. 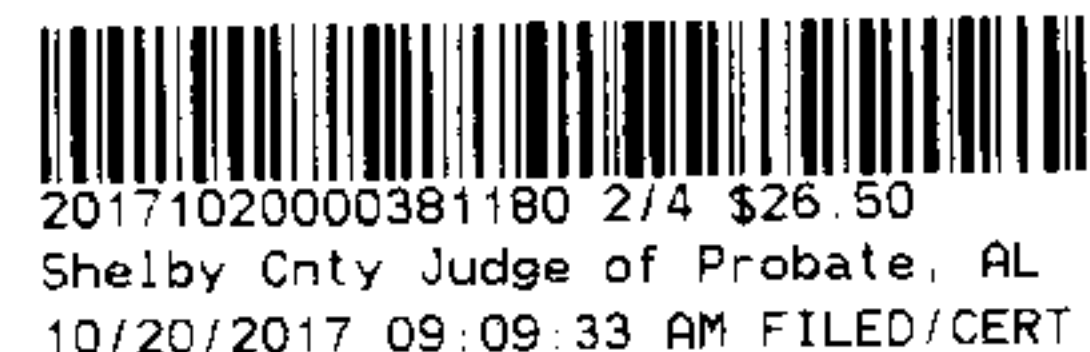

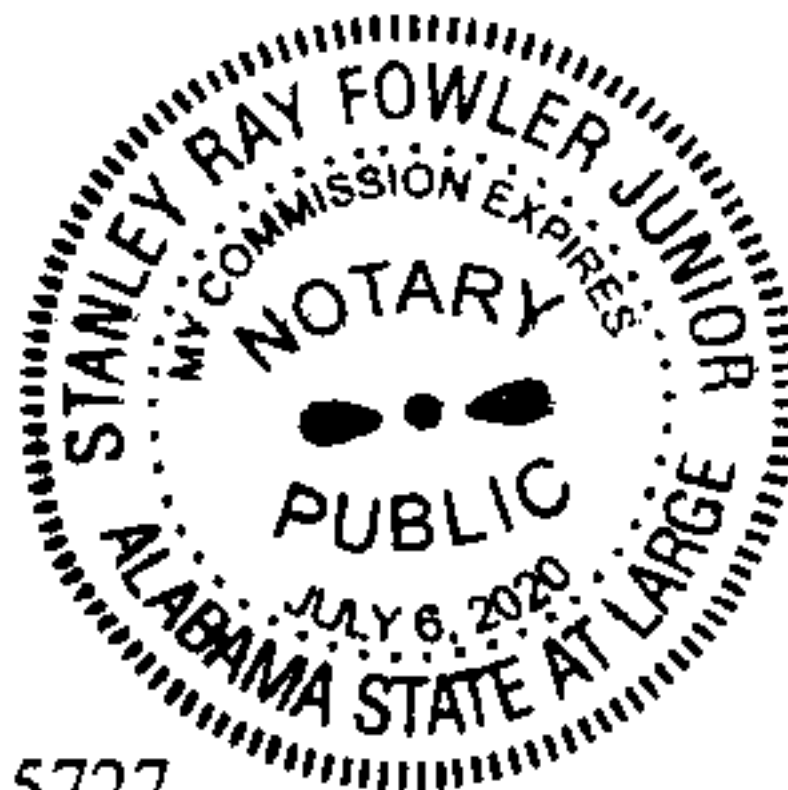

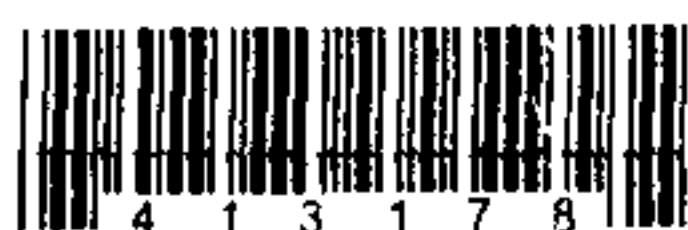
