
## ORDINANCE NO. 399-05



## AN ORDINANCE TO AMEND CHAPTER 2, ARTICLE II, SECTION 2-25 OF THE CODE OF ORDINANCES OF THE CITY OF PELHAM - COUNCIL MEETING RULES OF PROCEDURE

WHEREAS, the City of Pelham has determined that it is in the best interest of the City to amend Chapter 2, Article II, Section 2-25 Order of Business of Council Meetings of the Code of Ordinances, City of Pelham, Alabama.

NOW, THEREFORE BE IT ORDAINED by the Council of the City of Pelham, Alabama, that Chapter 2, Article II, Section 2-25 Order of Business of Council Meetings of the Code of Ordinances, City of Pelham, Alabama and the order of business in all instances for meetings of the council shall be amended as follows:

## I. ARTICLE II. COUNCIL MEETINGS

## Section 2-25. Order of Business.

The order of business shall be as follows:

- 1. A Call to Order
- 2. Invocation
- 3. Pledge of Allegiance
- 4. Record of Attendance
- Consent Agenda
   (Reading and/or approval of the minutes of the previous meeting, adopting current agenda and approval of non-controversial items pending action before the Council)
- 6. Public Hearings
- 7. Mayor's Comments
- 8. Proclamations by the Mayor
- 9. Report of the City Manager
- 10. Requests to Address the Council
- 11. Old Business Resolutions, Ordinances, Orders and Other Business
- 12. New Business Resolutions, Ordinances, Orders and Other Business
- 13. Council and Public Comments
- 14. Public Announcements
- 15. Adjournment
- II. The provisions of this Ordinance are severable. If any part of this Ordinance is declared invalid or unconstitutional, that declaration shall not affect the part which remains.
- III. This ordinance shall go into effect upon the passage and adoption by the City Council of the City of Pelham, Alabama and posting as required by law.
