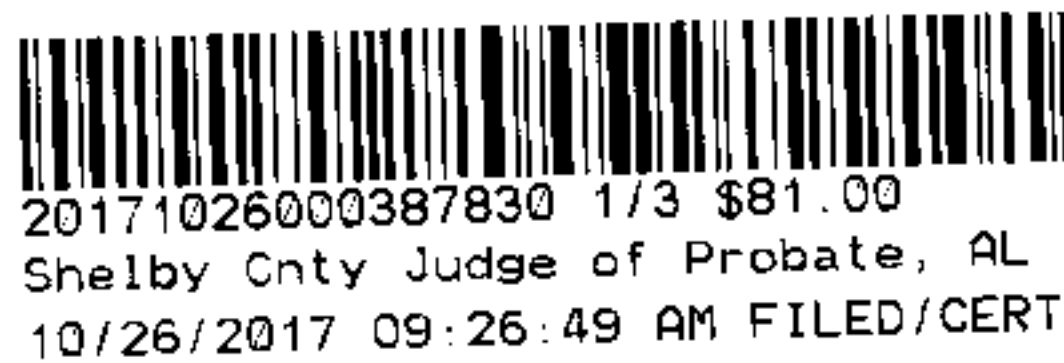

KNOW ALL MEN BY THESE PRESENTS, That in consideration of **Fine Nine Thousand, Nine Hundred and no/100's Dollars (\$59,900.00)** to the undersigned,

Winford Homecrafters, LLC, an Alabama limited liability company

hereinafter referred to as grantor, in hand paid by the grantees herein, the receipt whereof is hereby acknowledged the said grantors grant, bargain, sell and convey unto

Travis Robinson and Leann Robinson

hereinafter referred to as grantees as joint tenants with right of survivorship, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 26, according to the Survey of Maple Ridge Subdivision, as recorded in Map Book 37, Page 87, in the Probate Office of Shelby County, Alabama.


and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.



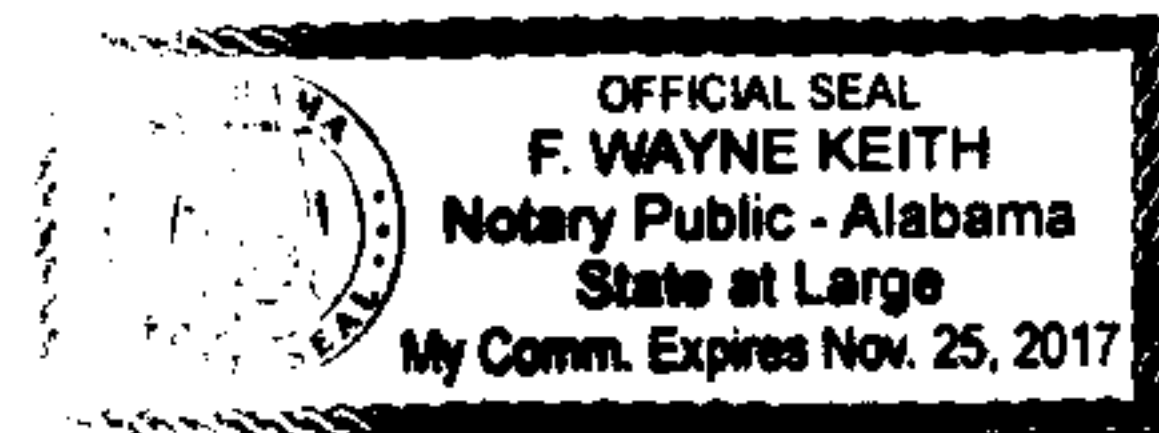
