FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on April 10, 2013, to-wit: Darnell K. Guyer and Frances Marilyn Guyer, husband and wife, executed a mortgage to Mortgage Electronic Registration Systems, Inc., solely as nominee for Discover Home Loans, Inc., A Delaware Corporation, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on April 25, 2013, in Instrument No. 20130425000168130, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded March 9, 2017 in Instrument No. 20170309000081470, Probate Records of Shelby County, Alabama; and

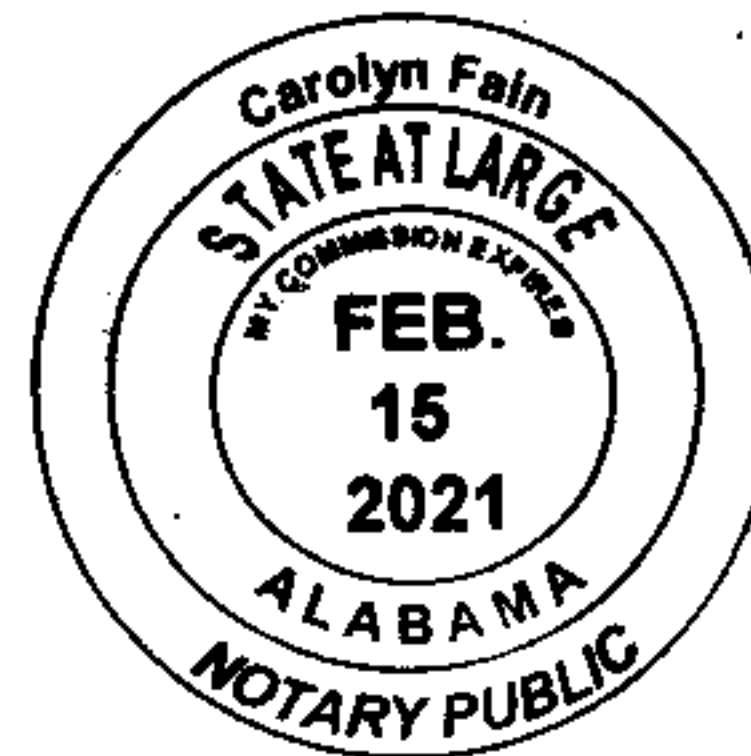

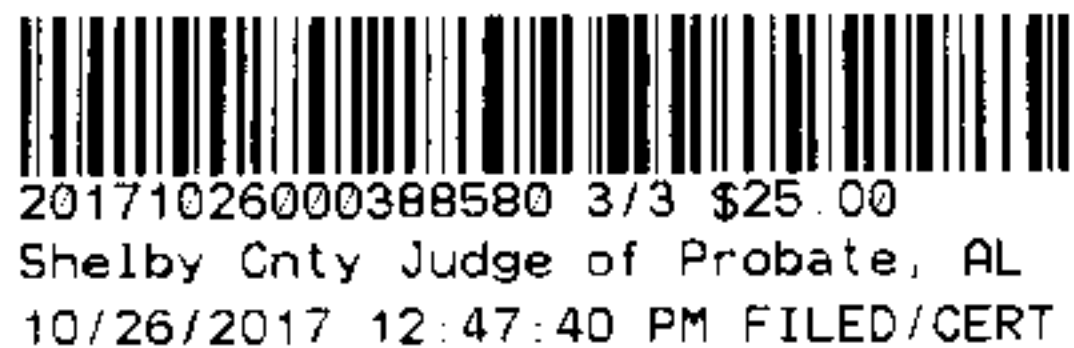
