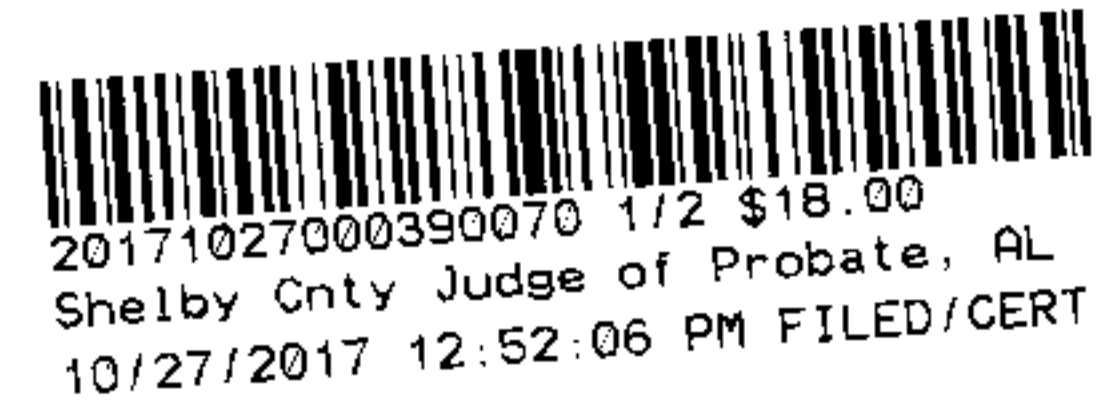


My agent has full power to act in my stead with no limitations. He has the Power to make decisions as if I were the one making those decisions.


