ARTICLES OF ORGANIZATION for
String Side Music, LLC

I, the undersigned, desiring to form a limited liability company pursuant to Title 10, Chapter 12 *Code of Alabama* (1975), certify as follows:

Article I: The name of the limited liability company is: **String Side Music, LLC**
(hereafter known as the "Company")

Article II: The name of the registered agent and the street and mailing address of the registered office of the limited liability company are as follows:

Birmingham, AL 35216

Article III: The existence of the Company shall commence on the date of filing of these Articles of Organization in the Office of the Judge of Probate of Shelby County, Alabama, and its duration shall be perpetual.

Article IV: The purposes for which the Company is organized are as follows:

- a) to engage in the business of publishing songs; songwriting; documenting lyrics; recording music; editing music and lyrics; selling merchandise; selling music; marketing artists and music; mixing audio; composing music; providing music to distributors; arranging and/or conducting live pay for play performances; scheduling events; audio mastering; album artwork; web design for artists; social media marketing and advertising; uploading music to streaming services; arranging mass production for audio distribution; providing audio in various formats for multimedia; arranging audio and/or video productions; and ensuring copyright procedures are followed for the protection of songwriters and music composers.
- b) to lease or acquire real and personal property for the purposes set out in paragraph (a);
- c) to borrow money and issue notes and other evidences of indebtedness, and to secure the payment or performance of its obligations by mortgage, deeds of trust, pledge, or otherwise;
- d) to draw, make, accept, endorse, discount, execute, or issue promissory notes, drafts, bills of exchange, or warrants, and other negotiable or transferable instruments;
- e) to enter into and make, perform, and carry out contracts of every kind and description made for lawful purposes, without limit as to amount, with any person, firm, association, limited liability company, or corporation, either public or private;
- f) to have one or more offices and to carry on all or any of the objects and purposes herein enumerated;
- g) to carry on any other lawful business permitted by Alabama law and to perform all acts in furtherance thereof.

The Company shall have all of the powers as set forth in Section 10-12-4, Code of Alabama (1975), as in effect from time to time, and such other powers as may be granted to limited liability companies in the State of Alabama or such other jurisdictions as the Company may be doing business from time to time.

Article V: The name and address of the initial member are as follows:

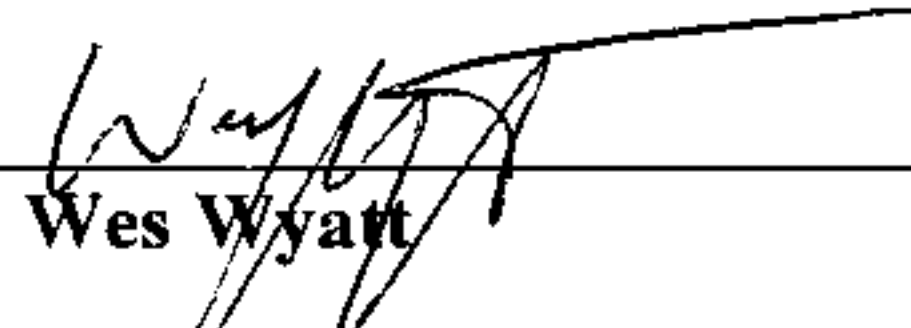
