**GENERAL WARRANTY DEED
With Right of Survivorship**

STATE OF ALABAMA }

KNOW ALL MEN BY THESE PRESENTS:

THAT IN CONSIDERATION OF **One Hundred Eighty-Seven Thousand Sixty-Five Dollars and NO/100 (\$187,065.00)** to the undersigned grantor, in hand paid by the Grantee herein, the receipt whereof is acknowledged, we, **James D. Reichard and Sara Reichard, husband and wife**, (herein referred to as **Grantors**), grant, sell, bargain and convey unto, **Michael J. Israel and Tekeisha L. Israel** (herein referred to as **Grantee** whether one or more), for and during their joint lives as joint tenants with rights of survivorship and upon the death of either of them, then to the survivor of them in fee simple, together with every contingent remainder or right of reversion, the following described real estate, situated in **SHELBY** County, Alabama to wit:

Lot 107, according to the Survey of Portsouth, Third Sector, as recorded in Map Book 7, Page 110, in the Office of the Judge of Probate of Shelby County, Alabama.

Subject to easements, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

\$ 183,676 of the above consideration was secured by and through the purchase money mortgage closed herewith.

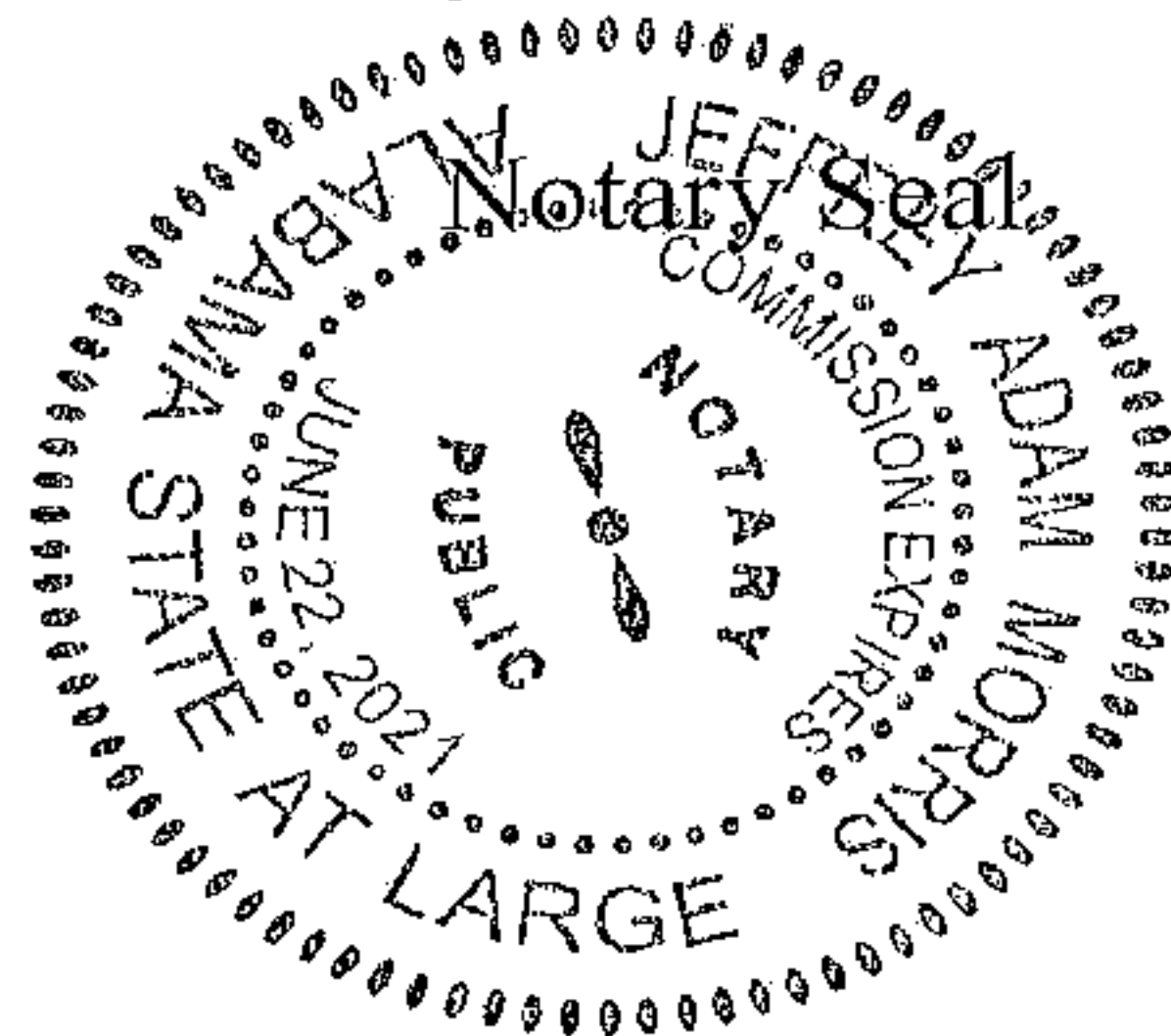

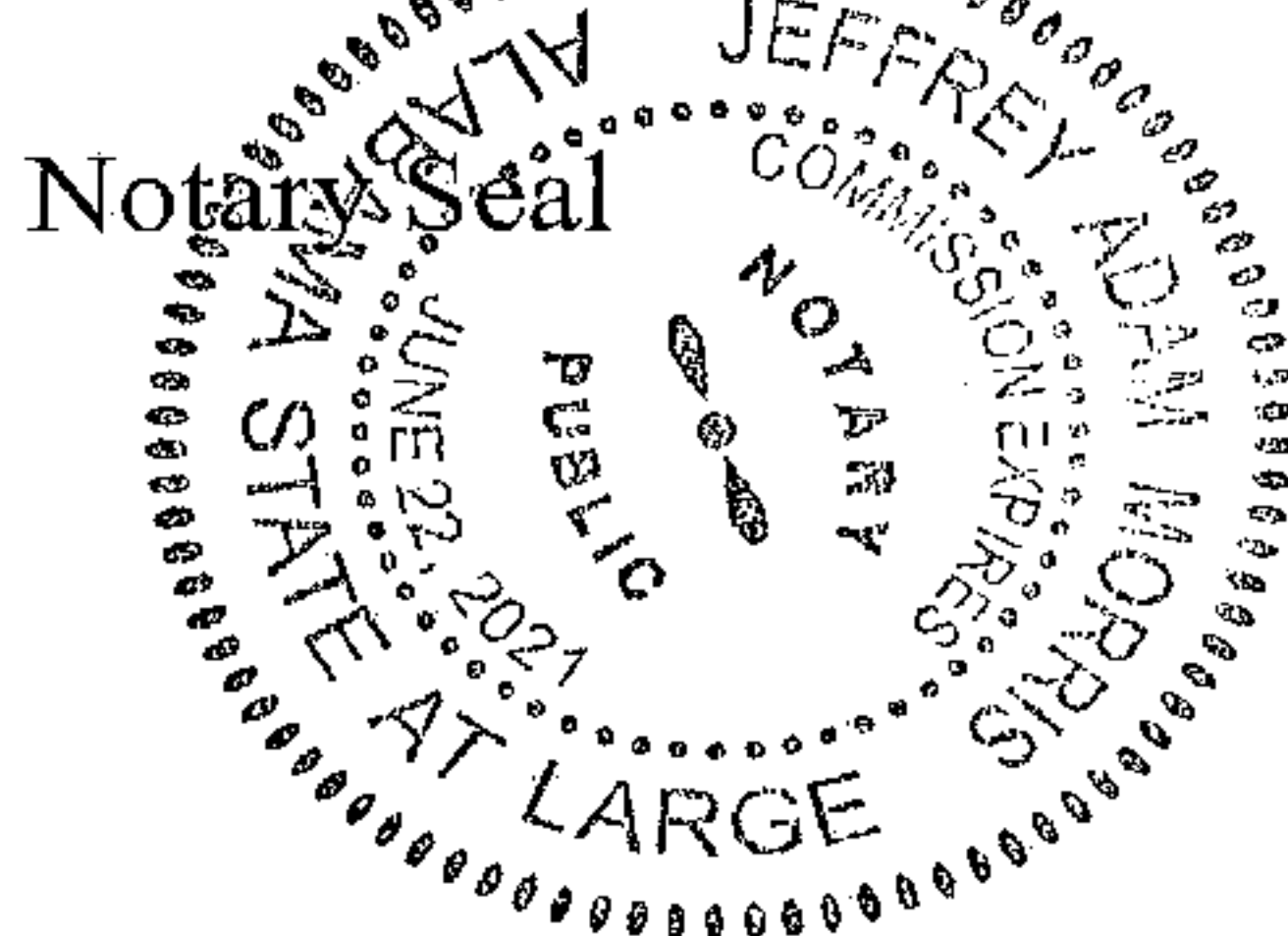
