## CERTIFICATION OF TRUST FOR The Stephen Howard Foster 2014 Trust

The undersigned, **Stephen Howard Foster**, Trustor and Trustee, being first duly sworn, depose and say, he is at least 19 years of age and is the currently acting trustee of The Stephen Howard Foster 2014 Trust, and further states as follows:

- There is a valid and existing trust, having been created by The Stephen Howard Foster 2014 Trust.
- 2. A. The original settlor(s) and successor settlor(s), if any, of the trust was/were:

  - B. The following person(s) contributed money, funds, real property, or personal property to the trust:

- C. The original settlor(s), **Stephen Howard Foster is** alive and well as of this date.
- D. The original trustee is Stephen Howard Foster.
- E. The name and address of the currently acting trustees:

- F. The Stephen Howard Foster 2014 Trust has definite beneficiaries. The named beneficiaries are not the sole trustee and sole beneficiary.
- The administrative and/or managerial powers of the trustee are set forth in the following selected provisions from the Declaration of Trust:

  Pursuant to the powers granted to the trustees in Section 9.2 *Powers of Trustees*,

  The trustee shall have all of the powers conferred on trustees by California law.

  These powers shall be deemed to include the power to invest in any kind of property without regard to statutory limitations; to perform any act that a prudent person would take in order to accomplish the objectives of the trust; to perform any act that prudent investor would take in investing trust property; to exercise any right or privilege that an unmarried competent adult has over individually owned property; and all other powers appropriate to achieve the proper investment, management, and distribution of the trust property.

Section 9.9 *Power to Direct Investments*. If I am not acting as the trustee, I may direct the trustee with respect to trust investments, specifically to direct the trustee to invest trust funds in specified securities, properties or other forms of investment; to retain as part of the trust estate, for specified periods of time, securities, properties, or other forms of investment held in the trust; and to sell, encumber, lease, abandon, or dispose of any trust property. If the trust assets are invested or retained in accordance with the terms of the settlor's written direction, the trustee shall not be liable for losses sustained as s direct or indirect result of the trustee's compliance with that direction.

- 4. The Trust is revocable.
- The following trustees have the authority to sign documents and instruments: **Stephen Howard Foster,** as Trustee.
- 6. Trust Property should be titled as follows: STEPHEN HOWARD FOSTER, as Trustee of the Stephen Howard Foster 2014 Trust.
- 7. To the best of the undersigned's knowledge, the trust has not been revoked, modified, or amended in any manner that would cause the representations and statements contained herein to be incorrect.
- 8. No person or entity paying money to or delivering property to my Trustee shall be required to see its application. All persons relying on this document regarding the Trustee and her powers over trust property shall be held harmless for any resulting loss or liability from such reliance. A Copy of this Certificate of Trust shall be just as valid as the original.
