## OATH OF OFFICE

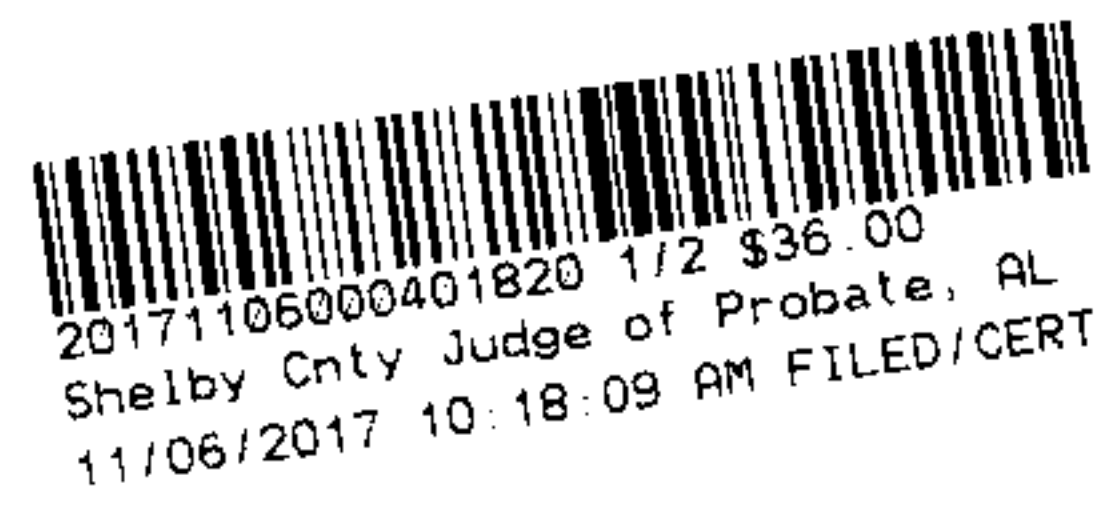
