

LIMITED POWER OF ATTORNEY

RNOW ALL MEN BY THESE PRESENTS, which are intended to constitute a Limited Durable Power of Attorney, that I, Julia Lucretia Bates McQuinn, of Lee County, State of Alabama, the undersigned, DO HEREBY MAKE, CONSTITUTE AND APPOINT Chelse Landis Nash, of Shelby County, State of Alabama, as my true and lawful Attorney-in-Fact, for me and in my name, place and stead, and on my behalf and for my use and benefit, to do, perform and execute all and every act that I may legally do through an attorney-in-fact to engage in any real estate transaction regarding the property located at 195 Wilson Drive Montevallo, AL 35115, including, but not limited to, the power to sell, convey, and sign all documents in connection with said real estate transaction, and every proper power necessary to carry out the purposes for which this power is granted, with full power of substitution and revocation, hereby ratifying and affirming that which the said Chelse Landis Nash shall lawfully do or cause to be done by himself lawfully designated by virtue of the power herein conferred upon him.
