WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP

On this November 7, 2017, That for and in consideration of **TWO HUNDRED FIFTY THOUSAND AND NO/100 (\$250,000.00) DOLLARS**, and other good and valuable consideration, this day in hand paid to the undersigned GRANTOR **TARA LOGEL (WHO IS ONE AND THE SAME PERSON FORMERLY KNOWN AS TARA L. SARTIN)**, an **unmarried person**, (herein referred to as "Grantor"), in hand paid by the Grantees herein, the receipt whereof is hereby acknowledged, the Grantor does hereby give, grant, bargain, sell and convey unto the Grantees, **ALIZA S. BIRCHEAT and CHARLES C. BIRCHEAT**, (herein referred to as "Grantees"), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, all of the Grantor's interest in the following-described Real Estate situated in, **SHELBY COUNTY, ALABAMA**, to wit:
