MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 21st day of September, 2010, VALENCIA E. ARRINGTON AND BENJAMIN R. ARRINGTON, II, WIFE AND HUSBAND executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS, INC. AS NOMINEE FOR FAIRWAY INDEPENDENT MORTGAGE CORPORATION, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on September 28, 2010, at Instrument Number 20100928000318390 (see Order recorded at 20170522000177570), Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to **FAIRWAY INDEPENDENT MORTGAGE CORPORATION**, by instrument recorded in at Instrument Number 20150819000288310, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, in and by said mortgage, the Transferee was authorized and empowered in case of default in the payment of the indebtedness secured thereby, according to the terms thereof, to sell said property before the Courthouse door in Shelby County, Alabama, after giving notice of the time, place, and terms of said sale in a newspaper published in said County by publication once a week for three (3) consecutive weeks prior to said sale at public outcry for cash, to the highest bidder, and said mortgage provided that in case of sale under the power and authority contained in same, the Transferee or any person conducting said sale for the Transferee was authorized to execute title to the purchaser at said sale; and it was further provided in and by said mortgage that the Transferee may bid at the sale and purchase said property if the highest bidder thereof; and

WHEREAS, default was made in accordance with the loan terms, and Fairway Independent Mortgage Corporation did declare due all of the indebtedness secured by said mortgage, subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of May 4th, 2016, October 4, 2017, October 11, 2017, October 18, 2017, that the property would be sold on November 1, 2017; and

WHEREAS, on November 1, 2017, the day on which the foreclosure was due to be held under the terms of the said notice, between the legal hours of sale, said foreclosure was duly conducted, and Fairway Independent Mortgage Corporation did offer for sale and sell at public outcry in front of the Courthouse door in Shelby County, Alabama, the property hereinafter described; and

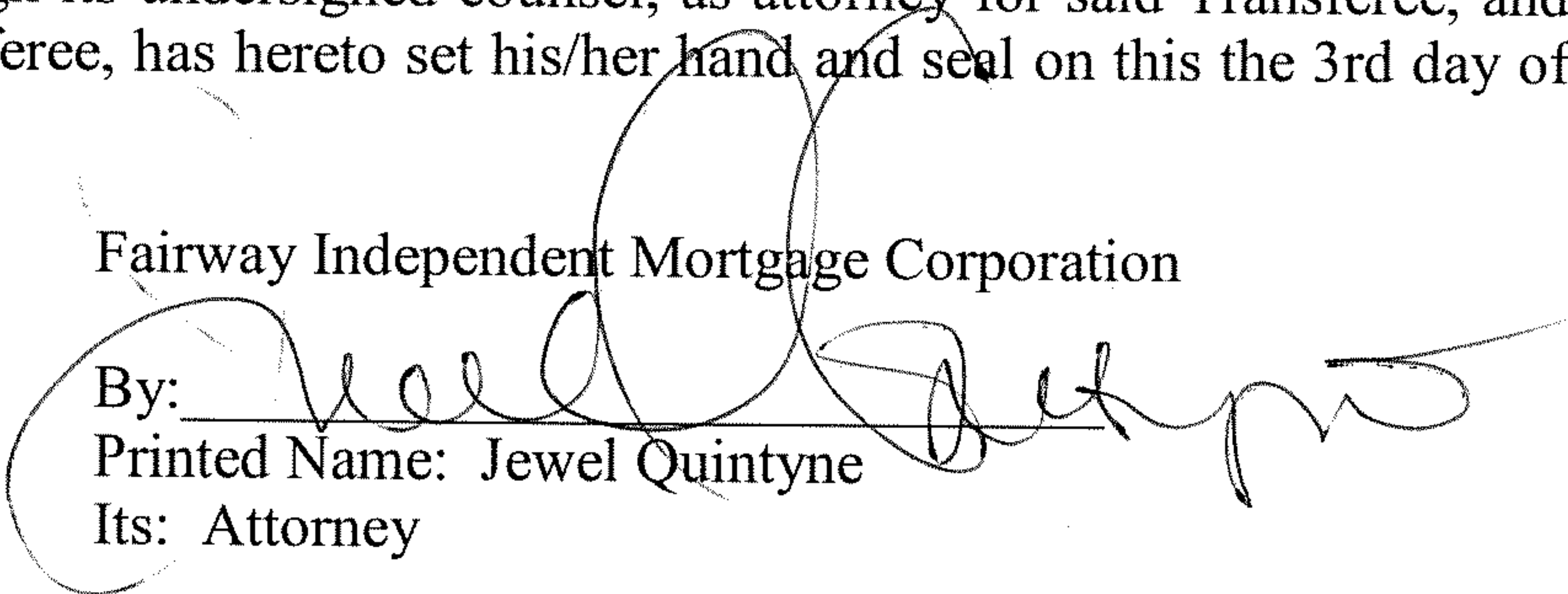

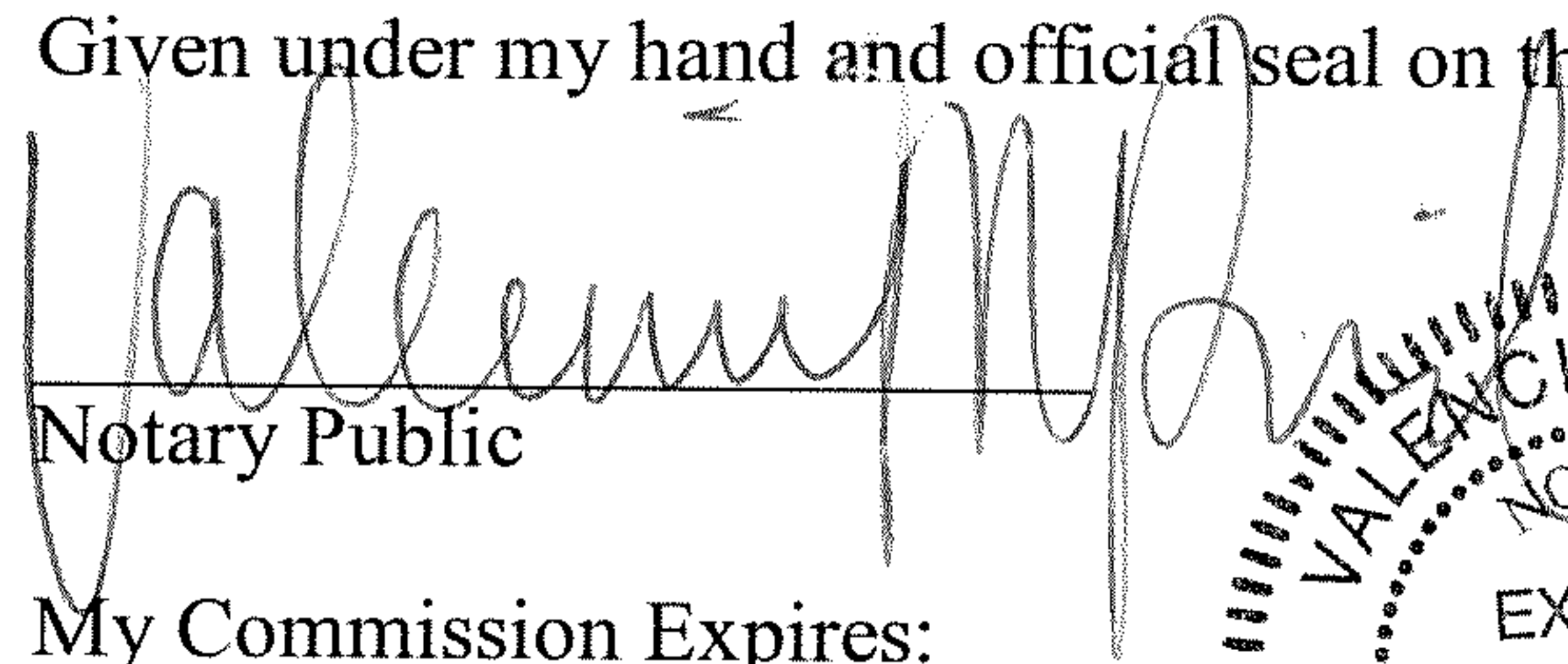
