WARRANTY DEED

Wallace, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Verna S. Belliveau and Shauna Griffin (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

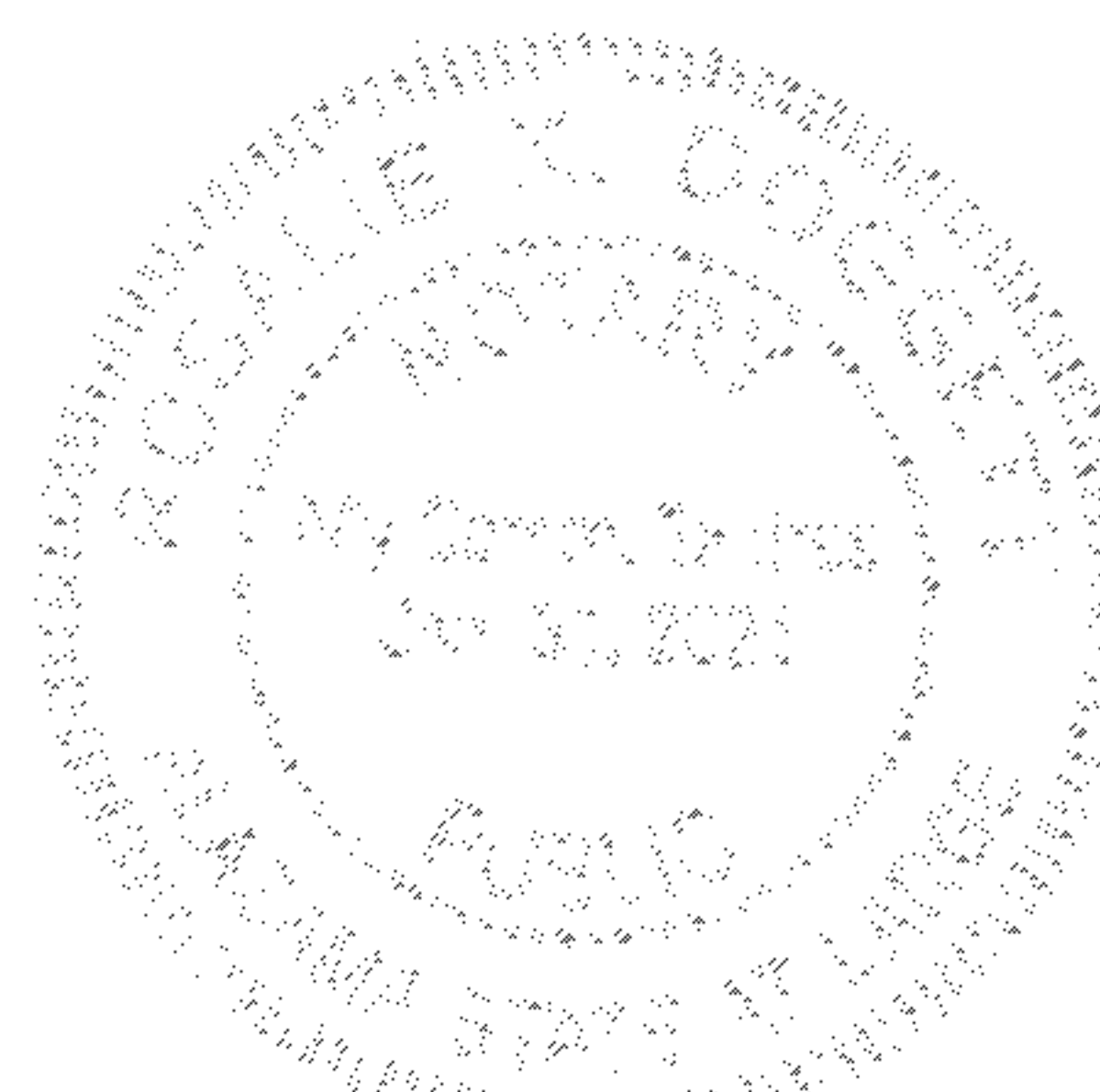
