

MORTGAGE FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, That

WHEREAS, heretofore, on, to-wit: the 17th day of December, 2004, ERIN VIRCIGLIO, AN UNMARRIED FEMALE executed that certain mortgage on real property hereinafter described to MORTGAGE ELECTRONIC REGISTRATION SYSTEMS INC AS NOMINEE FOR PRIMARY CAPITAL ADVISORS LC, which said mortgage was recorded in the Office of the Judge of Probate in Shelby County, Alabama, on December 21, 2004, at Instrument Number 20041221000695920, Shelby County, Alabama Records, said Mortgage having subsequently been transferred and assigned to NATIONSTAR MORTGAGE LLC D/B/A MR. COOPER, by instrument recorded in at Instrument Number 20170919000341550, in the aforesaid Probate Office ("Transferee"); and

WHEREAS, default was made in accordance with the loan terms, and Nationstar Mortgage LLC d/b/a Mr. Cooper did declare due all of the indebtedness secured by said mortgage, subject to foreclosure as therein provided and did give due and proper notice of the foreclosure of said mortgage by publication in the Shelby County Reporter, a newspaper of general circulation published in Shelby County, Alabama, in its issues of September 27, 2017, October 4, 2017, October 11, 2017, that the property would be sold on October 23, 2017; and

WHEREAS, on October 23, 2017, the day on which the foreclosure was due to be held under the terms of the said notice, between the legal hours of sale, said foreclosure was duly conducted, and Nationstar Mortgage LLC d/b/a Mr. Cooper did offer for sale and sell at public outcry in front of the Courthouse door in Shelby County, Alabama, the property hereinafter described; and

WHEREAS, RENTAL RESOURCE GROUP, LLC was the highest bidder in the amount of Eighty-Three Thousand Five Hundred Eighty-Eight and 80/100 dollars (\$83,588.80), on the indebtedness secured by said mortgage; and Nationstar Mortgage LLC d/b/a Mr. Cooper, by and through its undersigned counsel, does hereby grant, bargain, sell and convey unto RENTAL RESOURCE GROUP, LLC, all of its right, title, and interest in and to the following described property situated in Shelby County, Alabama, to wit:
