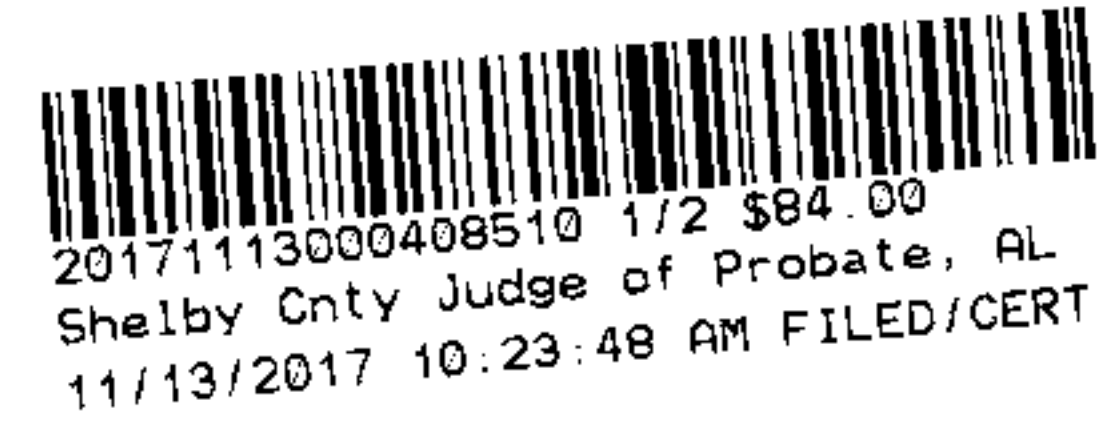


**SECOND

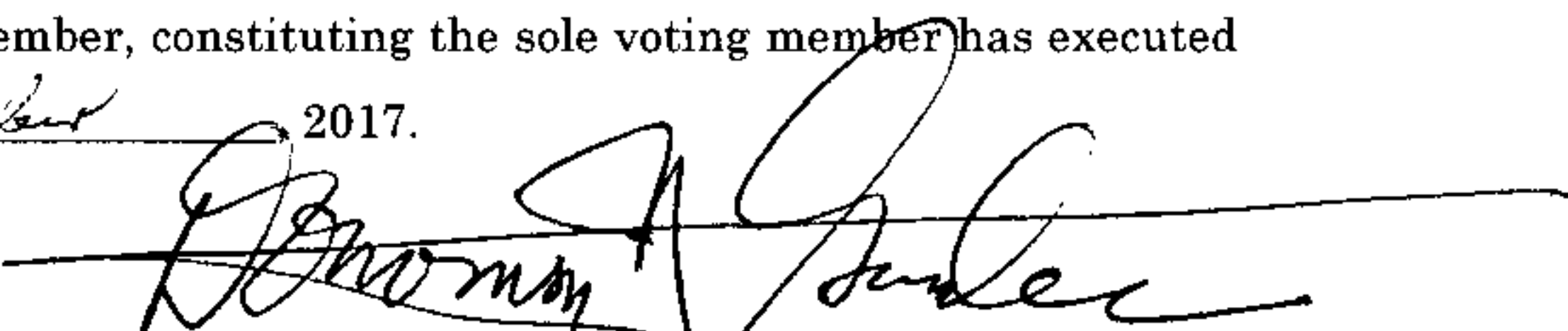
FIRST: The name of the Company currently is Forest Creeks Farm, LLC.

THIRD: On December 17, 2015, an Amendment to the Certificate of Formation of the LLC was filed changing the name of the LLC from Gravlee Farm, LLC to Forest Creeks Farm, LLC.

FOURTH: Upon approval of the sole voting member of the Company, the Certificate of Formation is hereby further amended to change the name of the Company from Forest Creeks Farm, LLC to Tallamahee Forest Creeks Farm, LLC, and any and all references to Forest Creeks Farm, LLC shall be deemed to refer to Tallamahee Forest Creeks Farm, LLC.
