\$107,000.00 of the proceeds come from a mortgage recorded simultaneously herewith.


- Subject to:

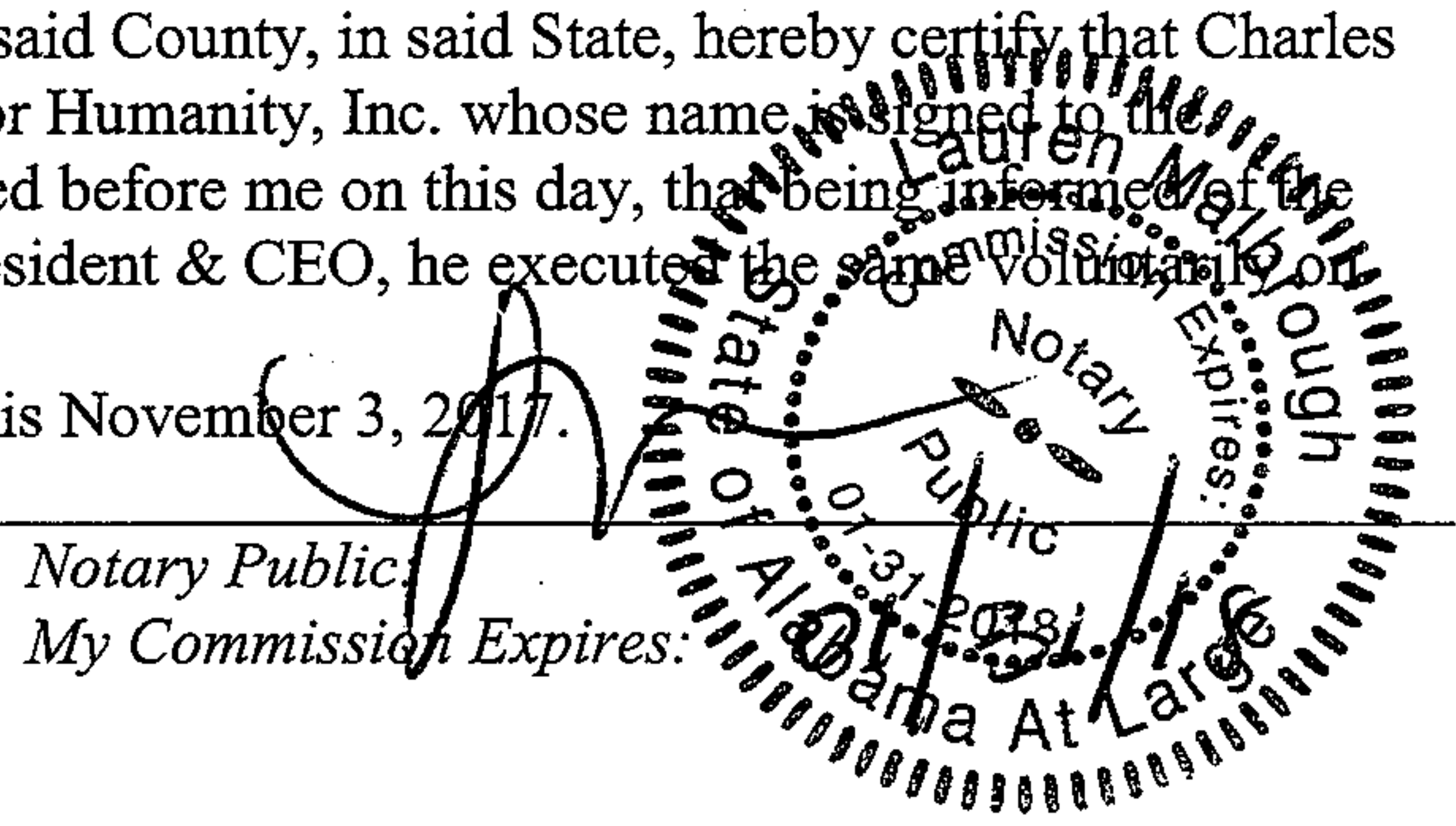

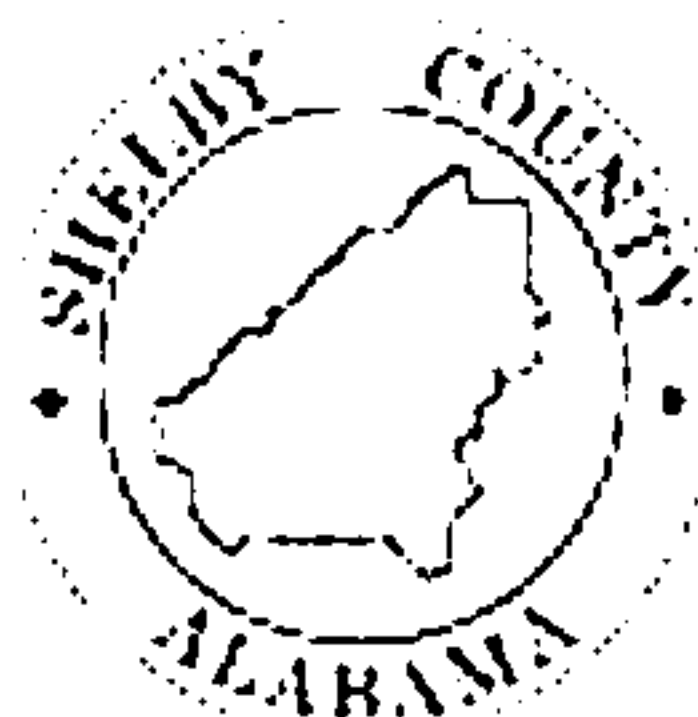
