Know All Men by These Presents, which are intended to constitute a Durable Power of Attorney, that I, JUDITH MORRISON TUMLIN, the undersigned, of Jefferson County, State of Alabama, do hereby make, constitute and appoint MICHAEL MORRISON AND MARK MORRISON as my true and lawful Attorneys-in-Fact, for me and in my name, place and stead, and on my behalf and for my use and benefit.

To exercise or perform any act, power, duty, right, or obligation whatsoever that I now have, or may hereafter acquire the legal right, power, or capacity to exercise or perform in connection with, arising from, or relating to any person, item, transaction, thing, business property, real or personal, tangible or intangible, or whatsoever.

I grant to my said Attorneys-in-Fact full power and authority to do, take, and perform all and every act and thing whatsoever requisite, proper, or necessary to be done, in the exercise of any of the rights and powers herein granted, as fully to all intents and purposes as I might or could do if personally present, with full power of substitution or revocation, hereby ratifying and confirming all that my said Attorneys-in-Fact shall lawfully do or cause to be done by virtue of this Power of Attorney and the rights and powers herein granted.

The rights, powers, and authority of my said Attorneys-in-Fact herein granted shall commence and be in full force and effect on April 3, 2009; The holder must have this power in hand for it to be effective. The authority conferred herein shall not be affected by disability, incompetency, or incapacity of the said principal; and such rights, powers and authority shall remain in full force and effect thereafter until revocation on written notice from the principal. Any action taken in good faith pursuant to the foregoing authority without actual knowledge of my death shall be binding upon me, my heirs, assigns and personal representatives. Any decision I make on my own behalf shall override that of the Attorneys-in-fact. This Power of Attorney terminates upon my death.

I, JUDITH MORRISON TUMLIN, hereby appoint MICHAEL MORRISON AND MARK MORRISON, who is now my Attorneys-in-Fact, as my guardians, curators, or other fiduciaries, as the case may be, in the event there is the necessity for the appointment of guardians, curators, or other fiduciaries concerning my estate or my person. I specifically waive the necessity for MICHAEL MORRISON AND MARK MORRISON to post a bond in said proceedings as guardians, curators, or other fiduciaries.

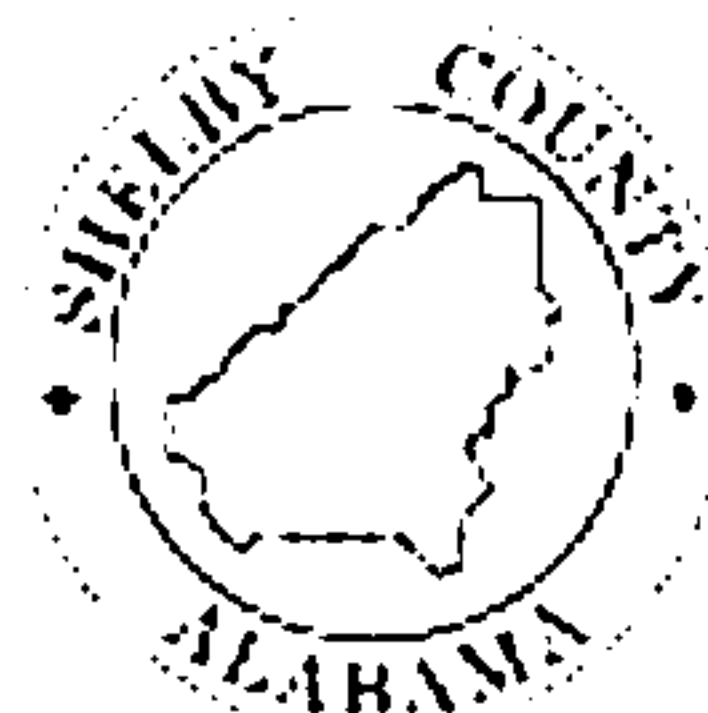
