Parcel I:

Commence at a concrete monument at the Southeast corner of the Southwest 1/4 of the Southeast 1/4 of Section 22, Township 19 South, Range 1 East, Shelby County, Alabama; thence go North along the East line of said 1/4-1/4 section 763.33 feet measured, 746.38 feet map, to a 6/8" rebar at the Point of Beginning of the parcel described herein; thence turn a right interior angle of 71° 55' 22" and go Southwesterly 247.53 feet to a 6/8" rebar in the center of a dirt driveway; thence turn a right interior angle of 24° 01' 04" seconds and go Easterly along the center of said driveway 169.27 feet to a 6/8" rebar; thence turn a right interior angle of 190° 55' 47" and continue Easterly along said driveway 70.28 feet to a 6/8" rebar on said East 1/4-1/4 section line; thence turn a right interior angle of 73° 04' 27" seconds and go North along said East line 114.85 feet to the Point of Beginning.

A parcel of land in the SW 1/4 - SE 1/4, Section 22, Township 19 South, Range 1 East Shelby County, Alabama, described as follows: From the SE corner of said 1/4-1/4 section, run northerly along the East 1/4-1/4 line for 746.38 feet to the point of beginning of subject parcel of land; from said point thus established run South 72° 25' 48" West for 290 feet; run thence North 01° 45' 36" West for 439.35 feet to a point on the North line of Grantor's land; thence run along the North line of said land North 89° 24' East for 290 feet back to the East 1/4-1/4 line; thence run southerly along said East 1/4-1/4 line for 384.61 feet, back to the beginning point being situated in Shelby County, Alabama.
