KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 15th day of November, 2013, Michael J. Shriver, and his spouse, Ellyn Shriver, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., as nominee for DHI Mortgage Company, Ltd., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument No. 20131122000459900, said mortgage having subsequently been transferred and assigned to PennyMac Loan Services, LLC, by instrument recorded in Instrument number 20170927000352480, in the aforesaid Probate Office ("Transferee"); and

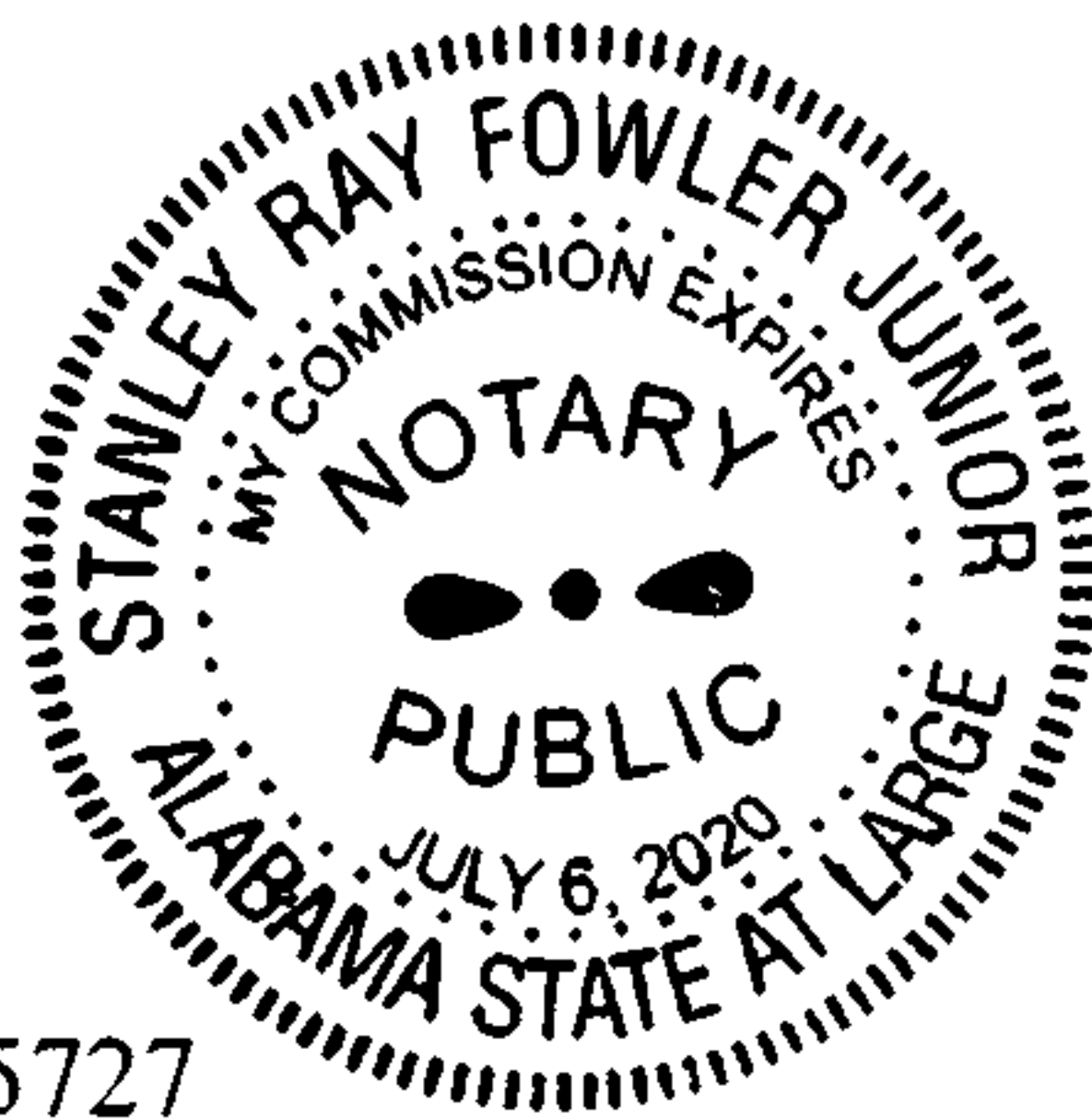

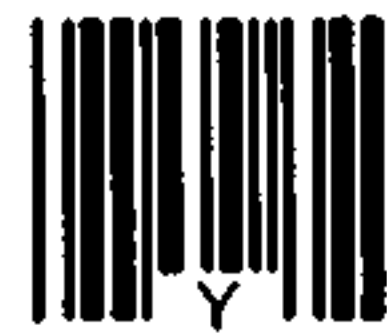

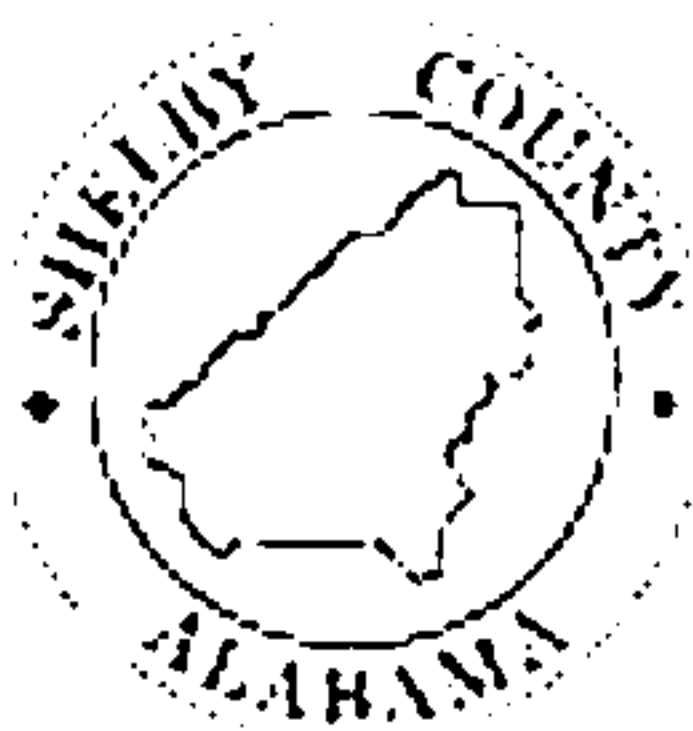
