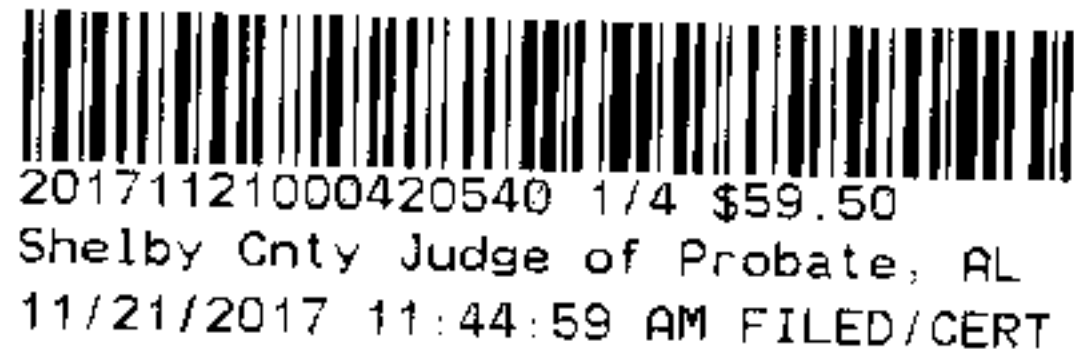

No part of the homestead of the Grantors herein or his spouse.


