The Association claims a lien upon property owned by **Michael & Rose Welch**, situated in Shelby County, Alabama described as follows:

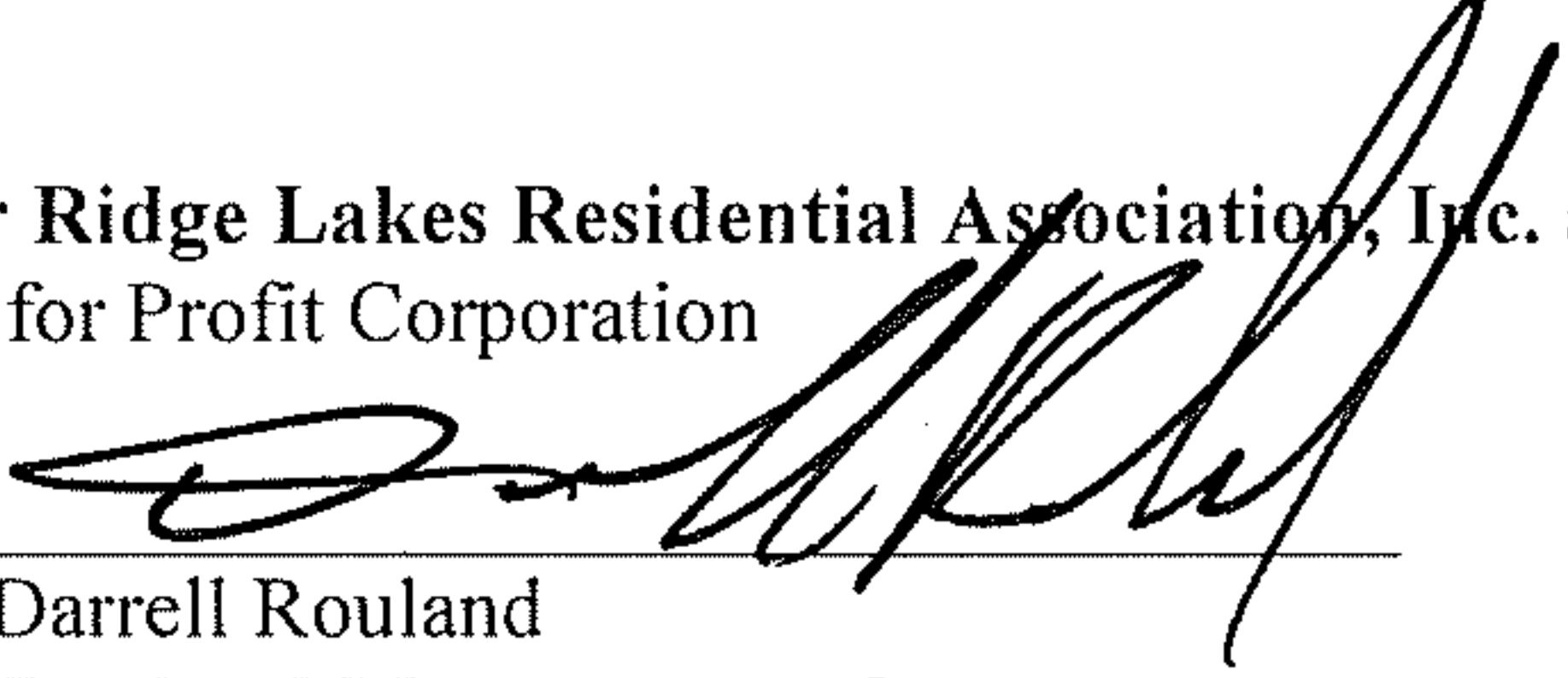
Lot 2, as recorded in Map Book 22, Page 80, Shelby County, Alabama records

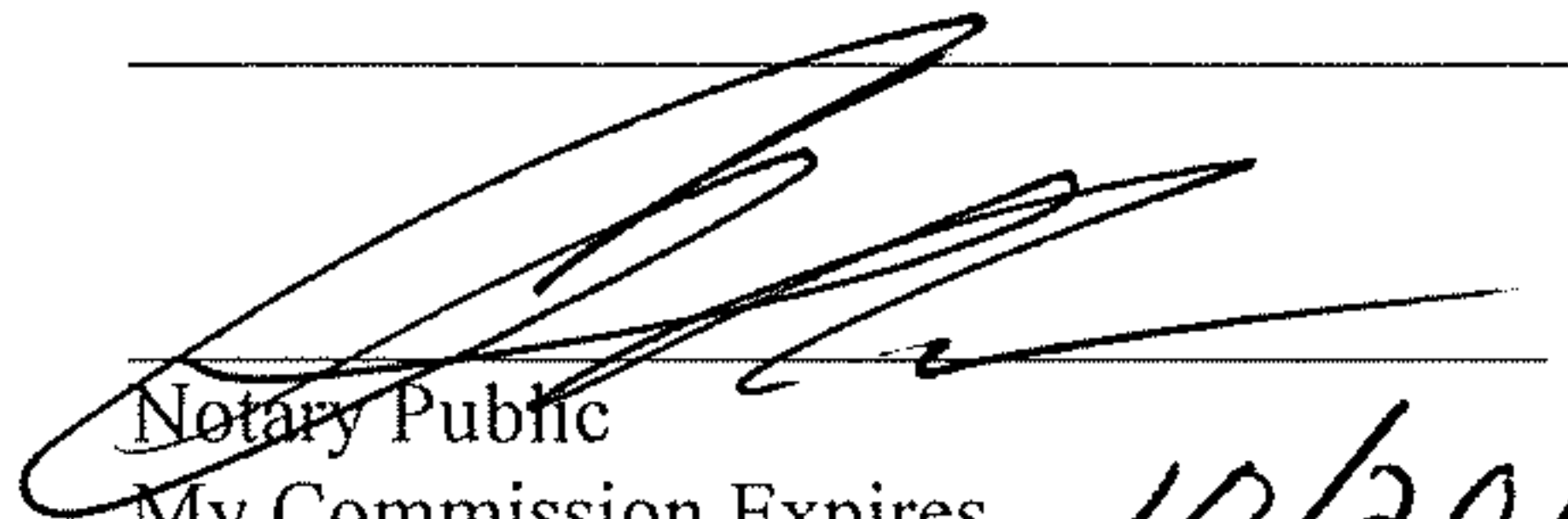

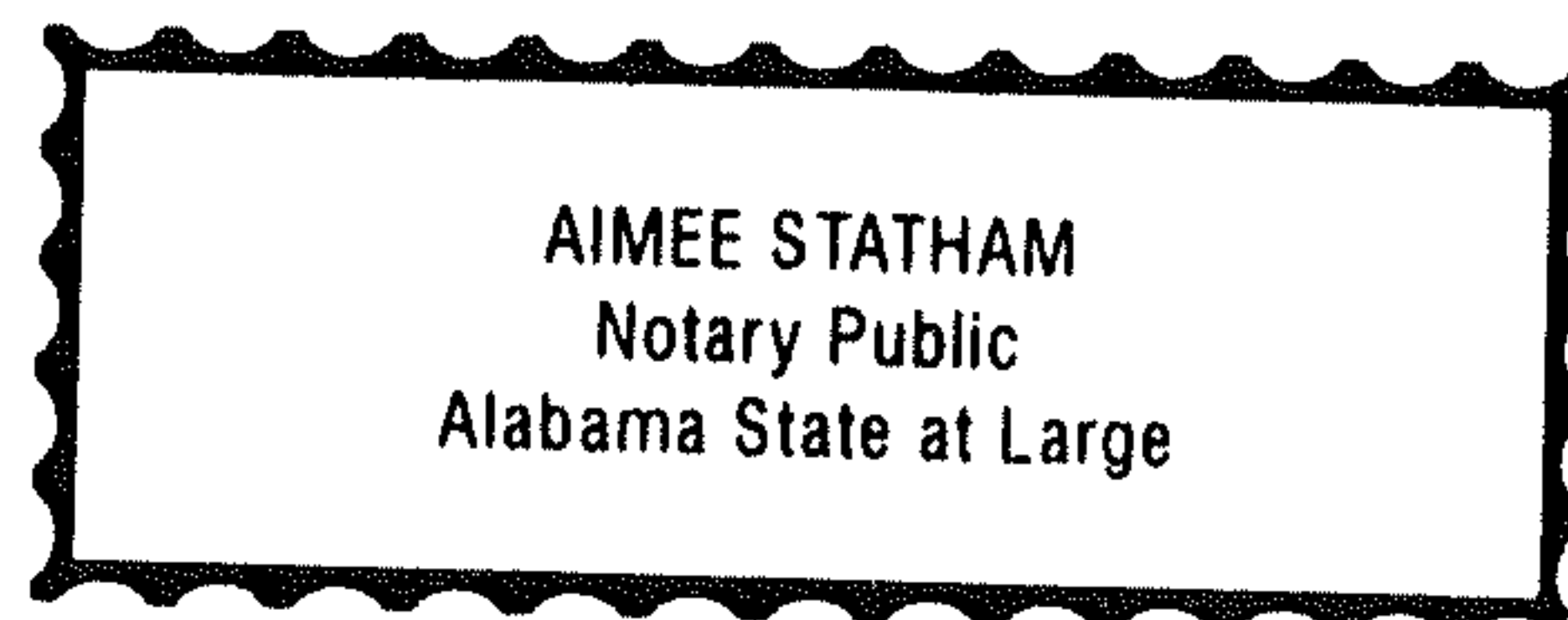
