The Association claims a lien upon property owned by **Chablis & Scott Schultz**, situated in Shelby County, Alabama described as follows:

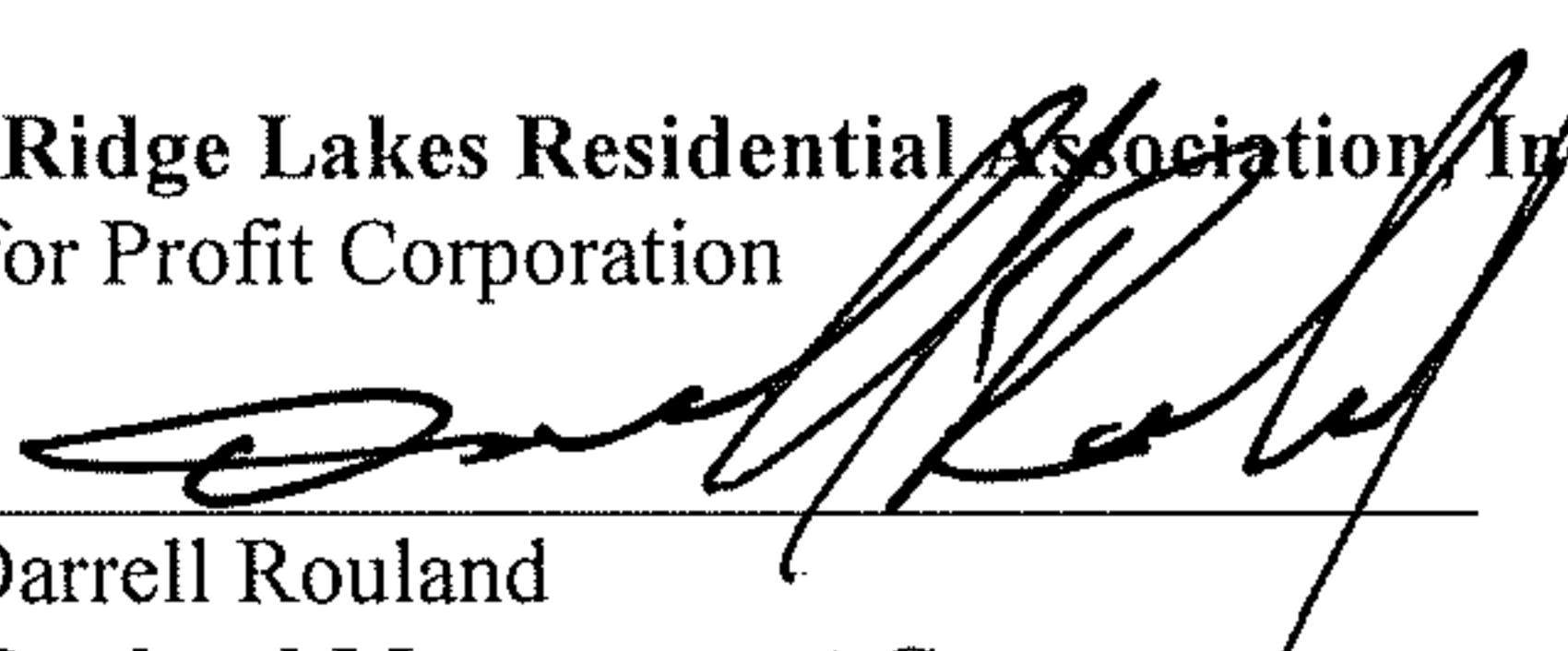

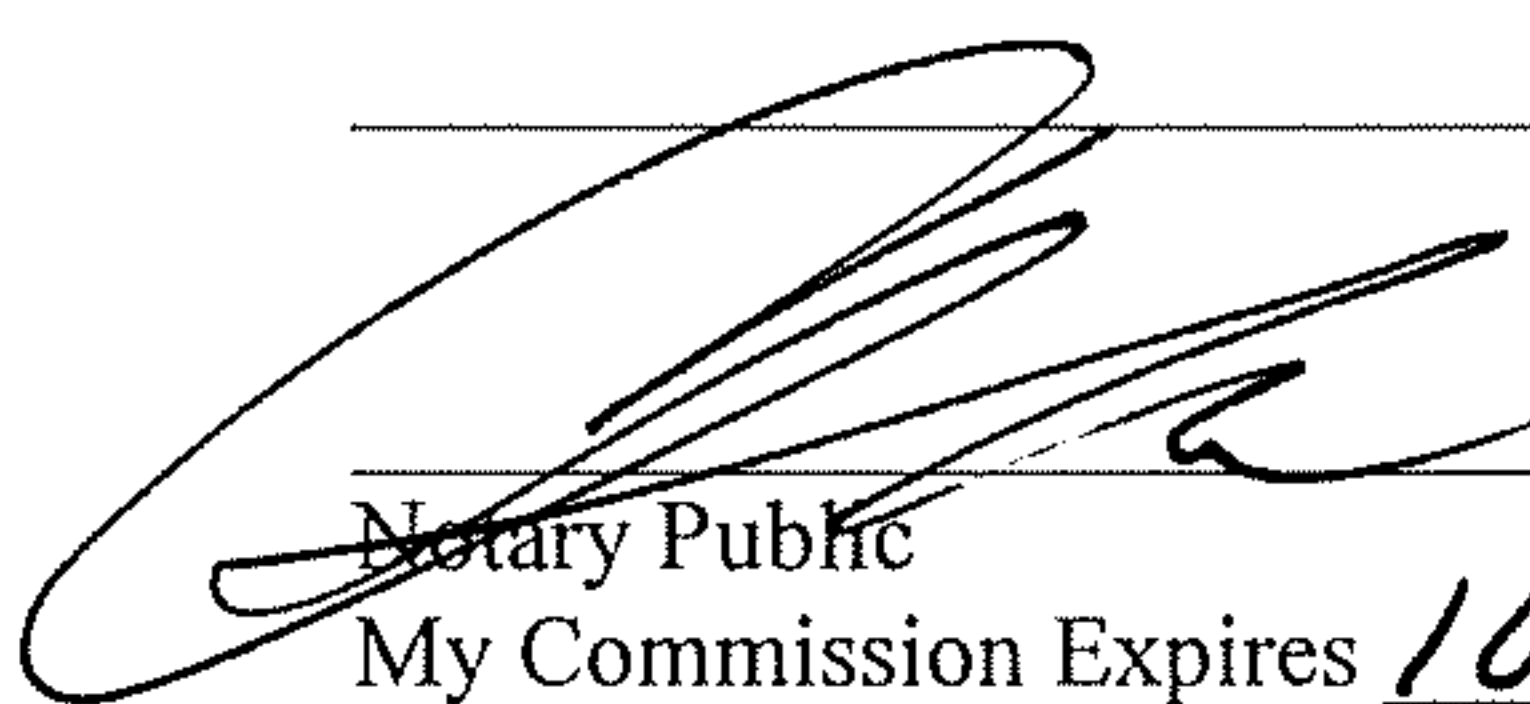

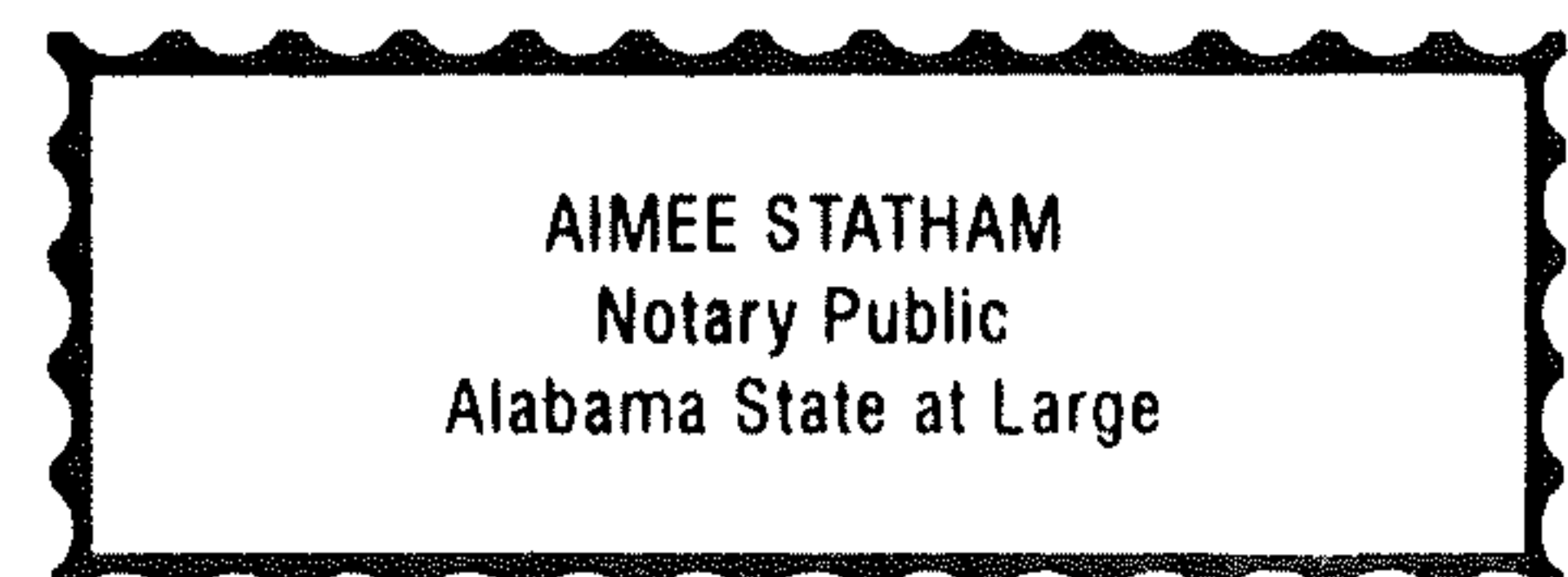
